**GENERAL WARRANTY DEED

THAT IN CONSIDERATION OF **Three Hundred Twenty-One Thousand Nine Hundred Dollars and NO/100 (\$321,900.00)** to the undersigned grantor, in hand paid by the Grantee herein, the receipt whereof is acknowledged, we, **Carl Wyatt and Janis Wyatt, husband and wife**, (herein referred to as **Grantors**), grant, sell, bargain and convey unto, **Melanie B. Holliman and John R. Holliman** (herein referred to as **Grantee** whether one or more), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in **Shelby County, Alabama** to wit:

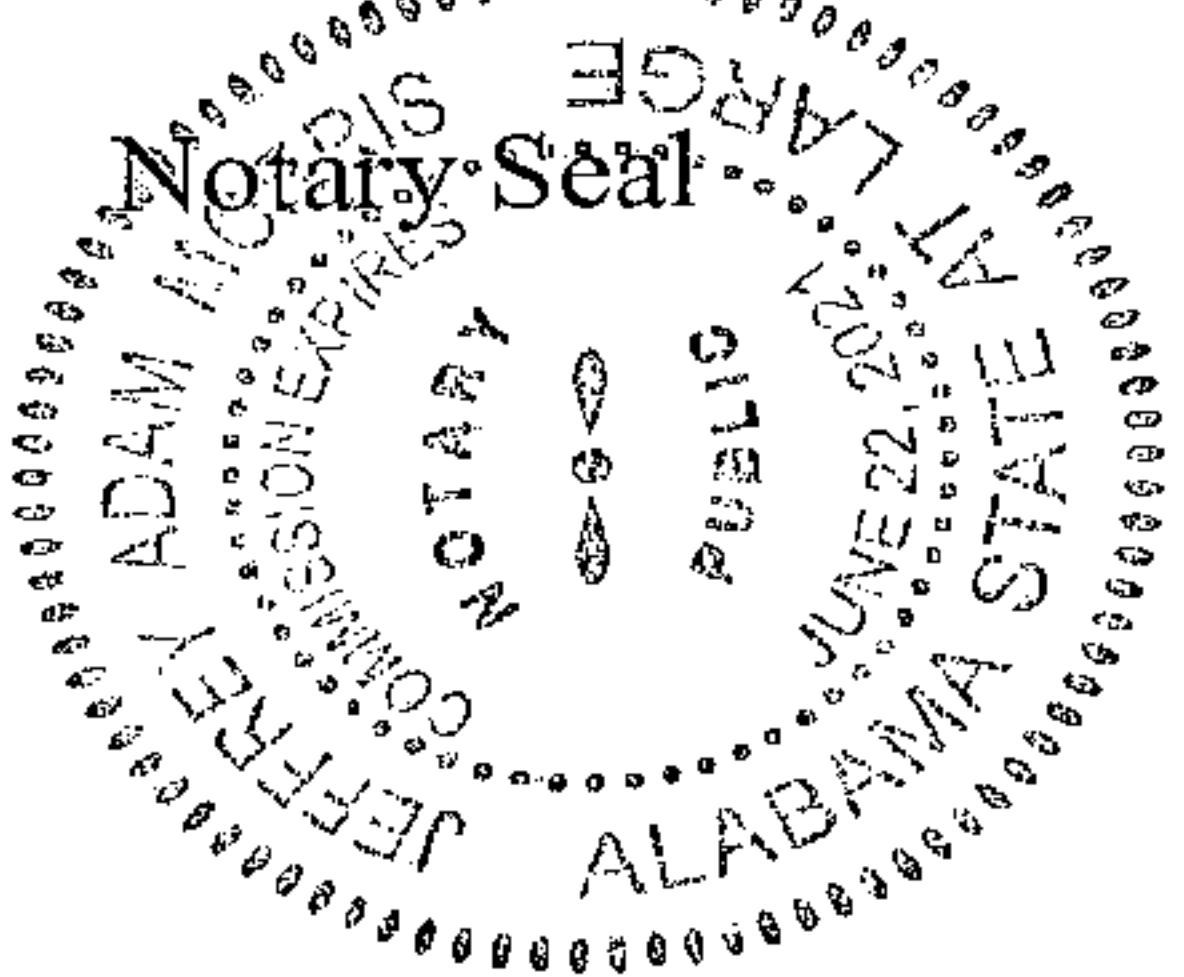

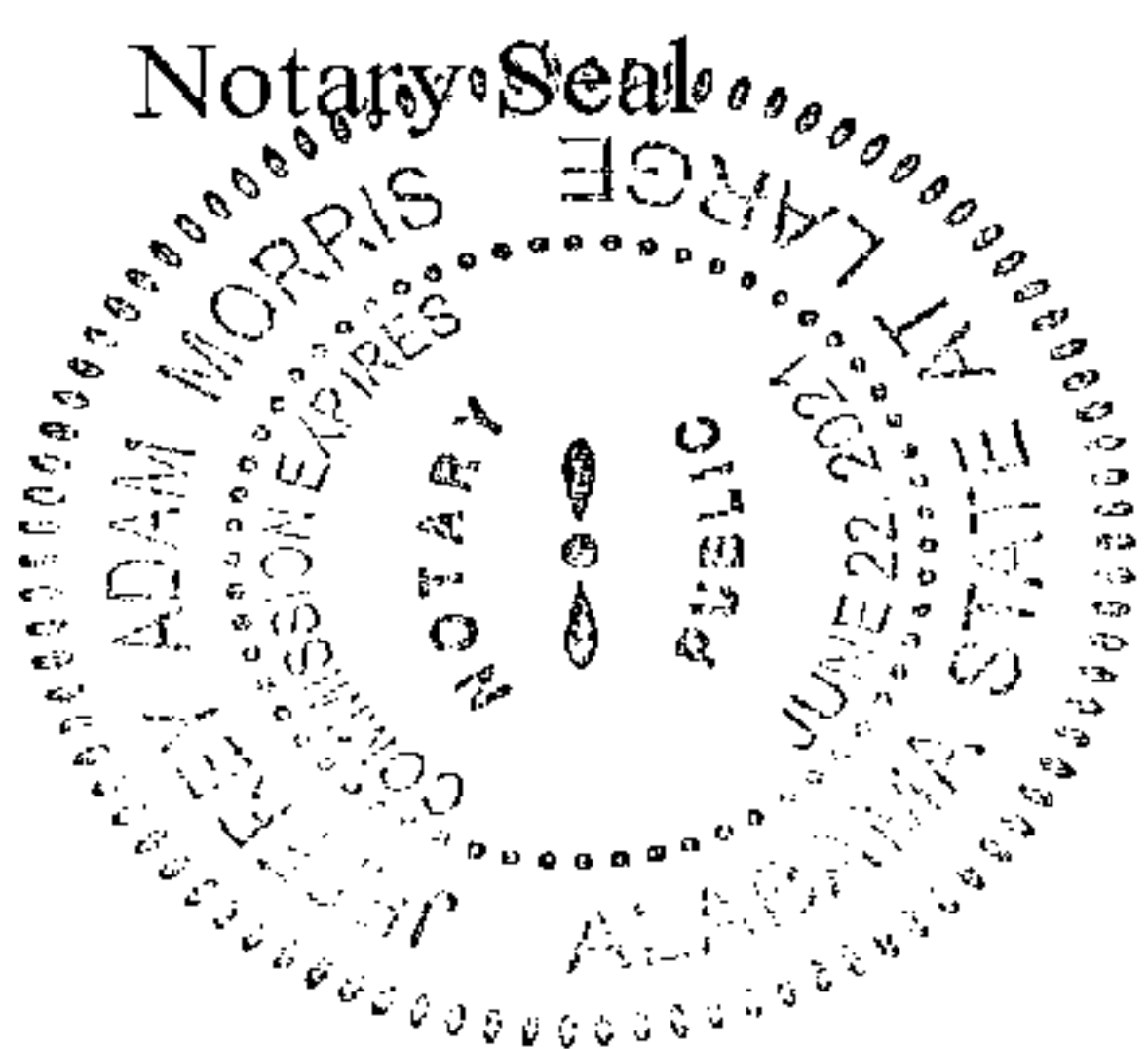
