**GENERAL WARRANTY DEED**

THAT IN CONSIDERATION OF **Three Hundred Thousand Dollars and NO/100 (\$300,000.00)** to the undersigned grantor, in hand paid by the Grantees herein, the receipt whereof is acknowledged, I, **Leigh Ann Alexander, a single person**, (herein referred to as **Grantor**), grant, sell, bargain and convey unto, **Rebecca Adams Carroll and Bradley Wayne Carroll** (herein referred to as **Grantee** whether one or more), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in **SHELBY** County, Alabama to wit:

Subject to easements, set back lines, restrictions, covenants, mineral and mining rights and current taxes due.


Rebecca Adams Carroll is formerly known as Rebecca C. Adams. They are one and the same person.

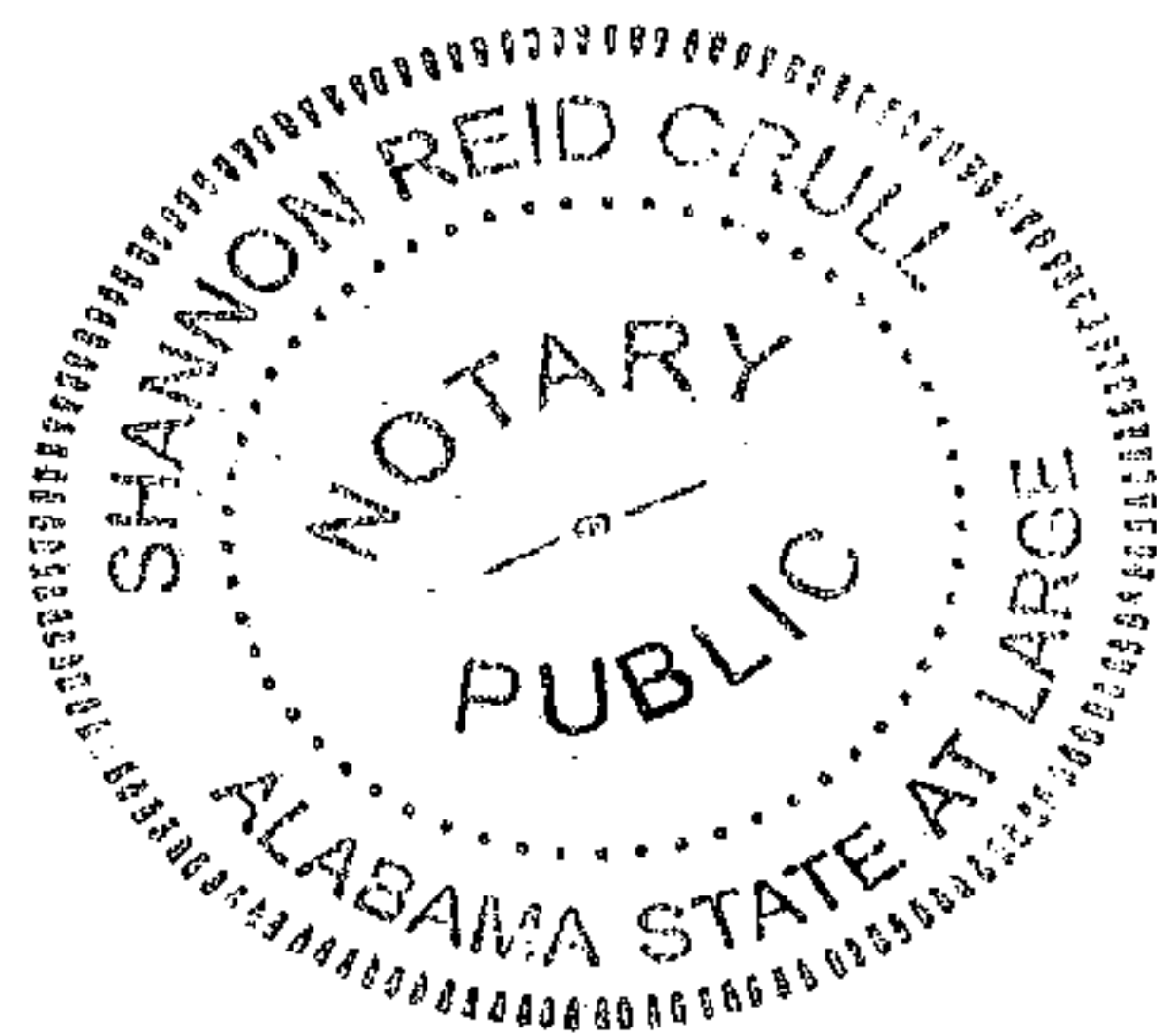


