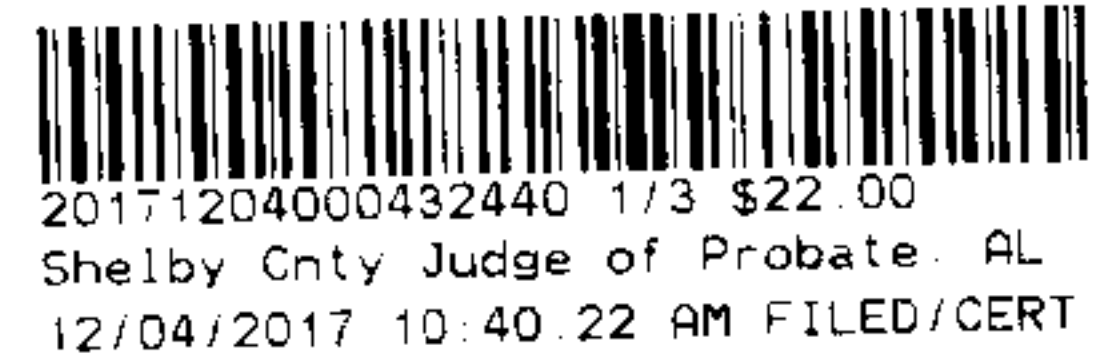


MORTGAGE FORECLOSURE DEED

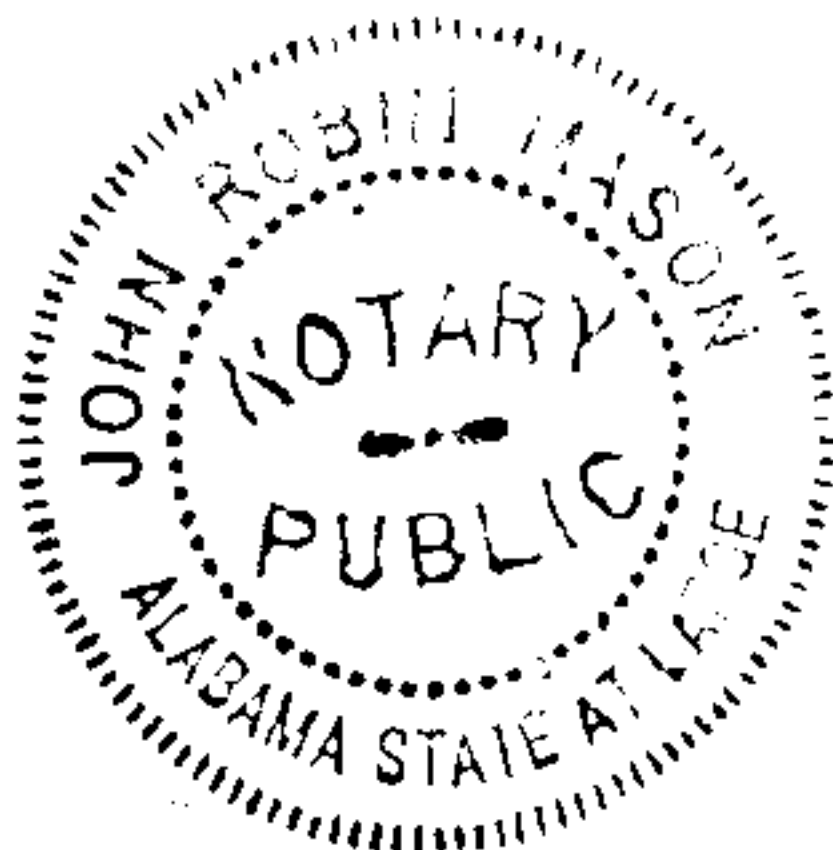

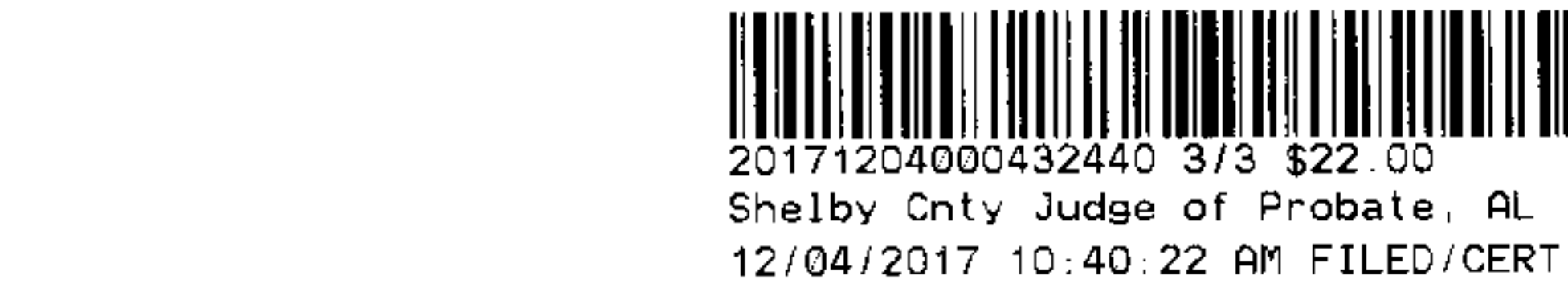
