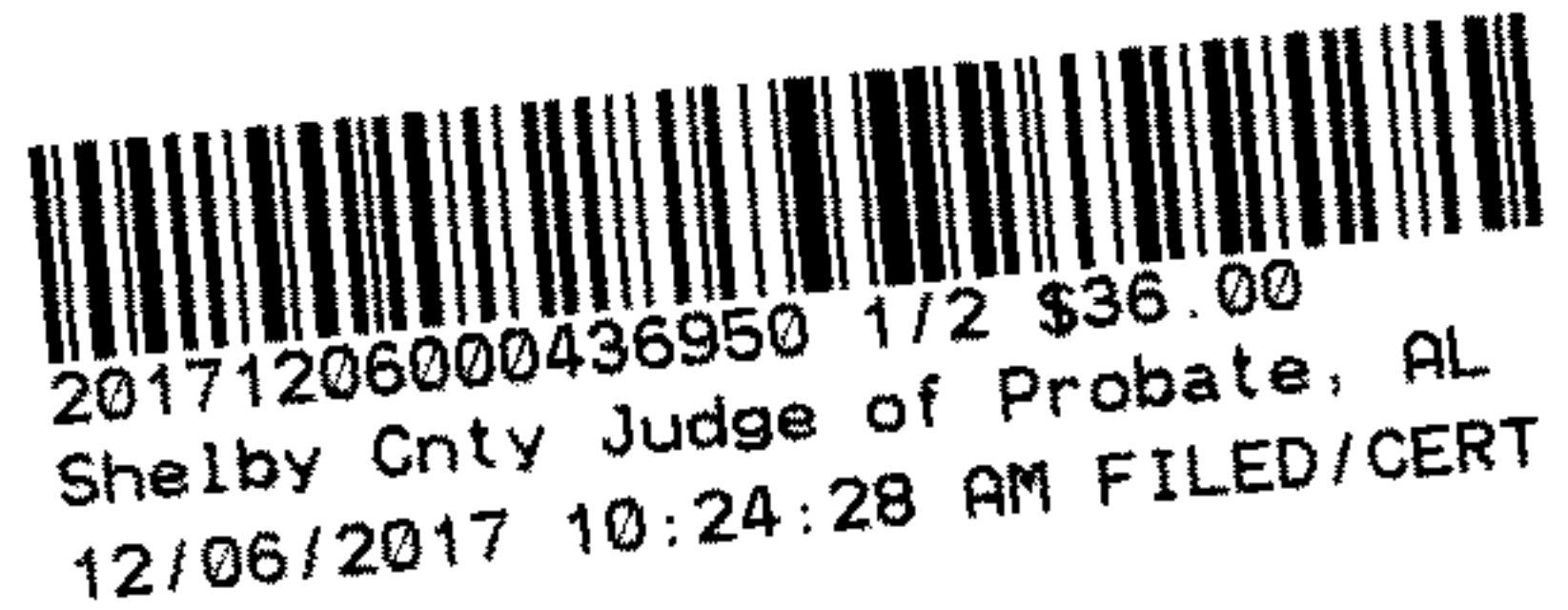


## NOTARY BOND
