KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 22nd day of August, 2007, Bradley W. Fish and Karen G. Fish, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Countrywide Bank, FSB, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 20070906000418850, said mortgage having subsequently been transferred and assigned to Ditech Financial LLC, by instrument recorded in Instrument number 20170809000287050, in the aforesaid Probate Office ("Transferee"); and

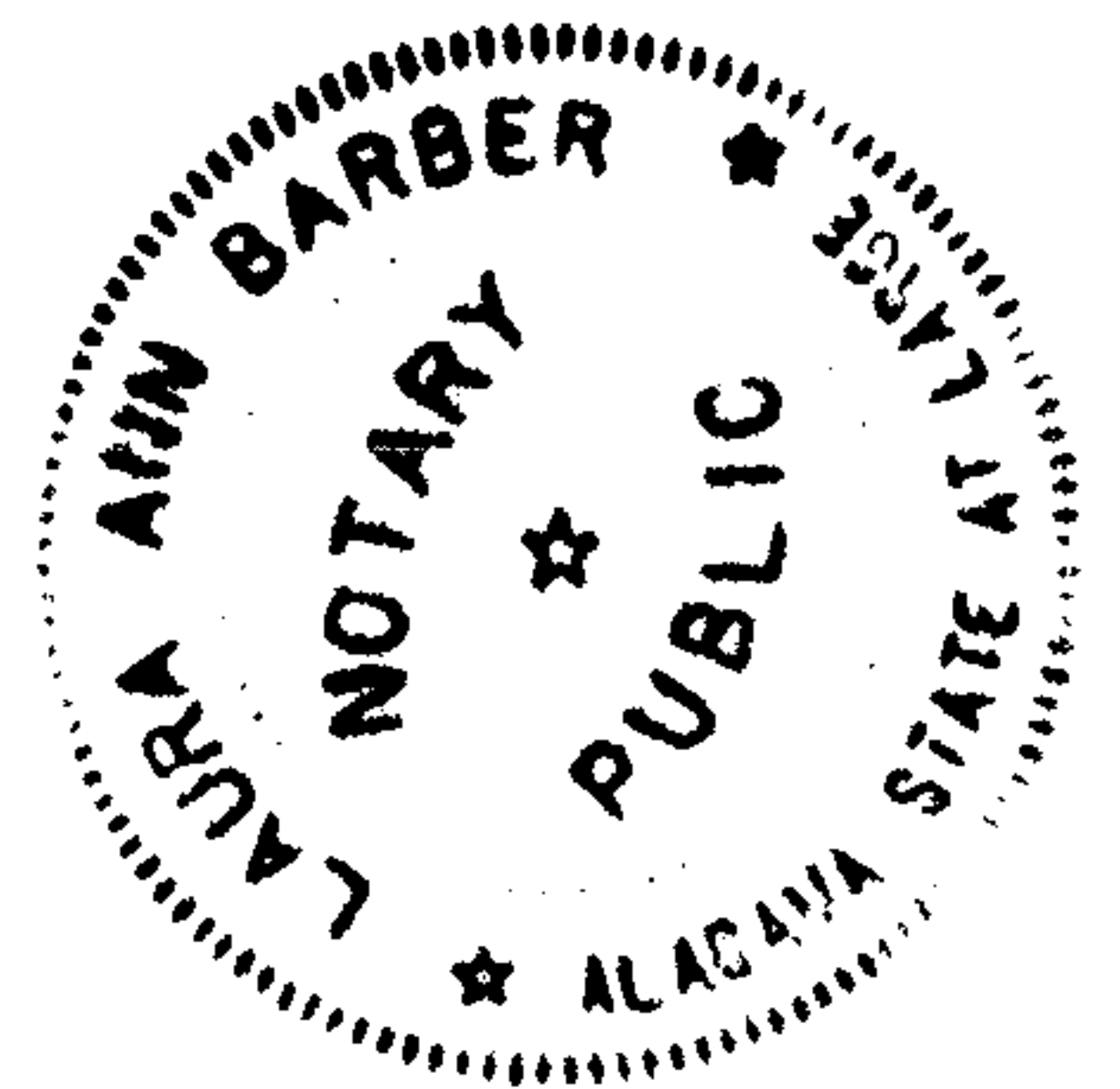

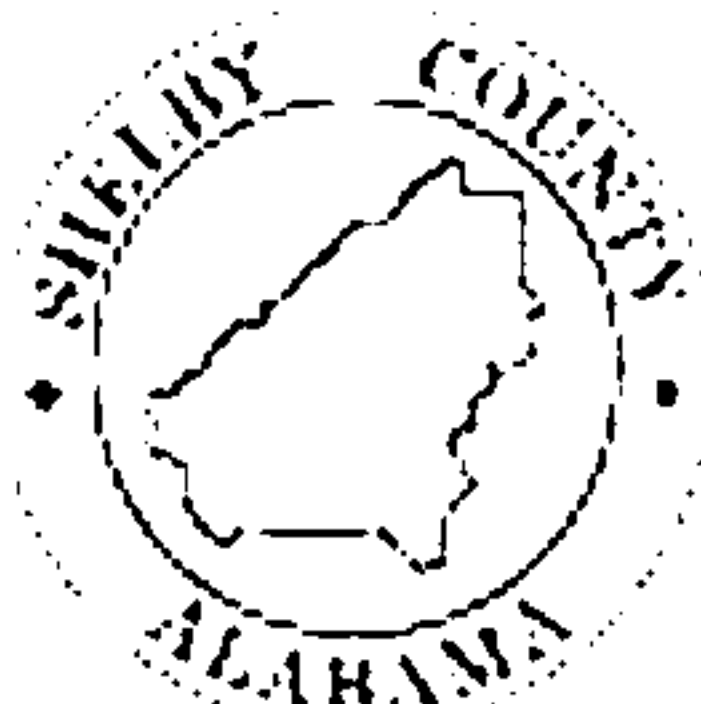
