C. The Interest Bearing Principal Balance will re-amortize over 349 months.

Interest will begin to accrue as of **NOVEMBER 01, 2017**. The first new monthly payment on the New Principal Balance will be due on **DECEMBER 01, 2017**, and monthly on the same date thereafter.

My payment schedule for the modified Loan is as follows:


