#### ARTICLE I

##### NAME

The name of this limited liability (the "Company") shall be **AJ's Roofing, LLC**.

#### ARTICLE II

##### DURATION

The period of duration is perpetual from the date of filing of these Articles of organization with the probate judge of Shelby County, unless the company shall sooner dissolve and its affairs are wound up in accordance with its Articles of Organization or Operating Agreement or extend the duration beyond the above stated term.

#### ARTICLE III

##### PURPOSE

The nature of the business of the Company and its objects, purpose and powers are and shall to develop and operate a **RESIDENTIAL AND COMMERCIAL ROOFING BUSINESS**, for profit, income, and appreciation, and to conduct or do any other lawful act or business permitted of the company under the Alabama Limited Company Act.



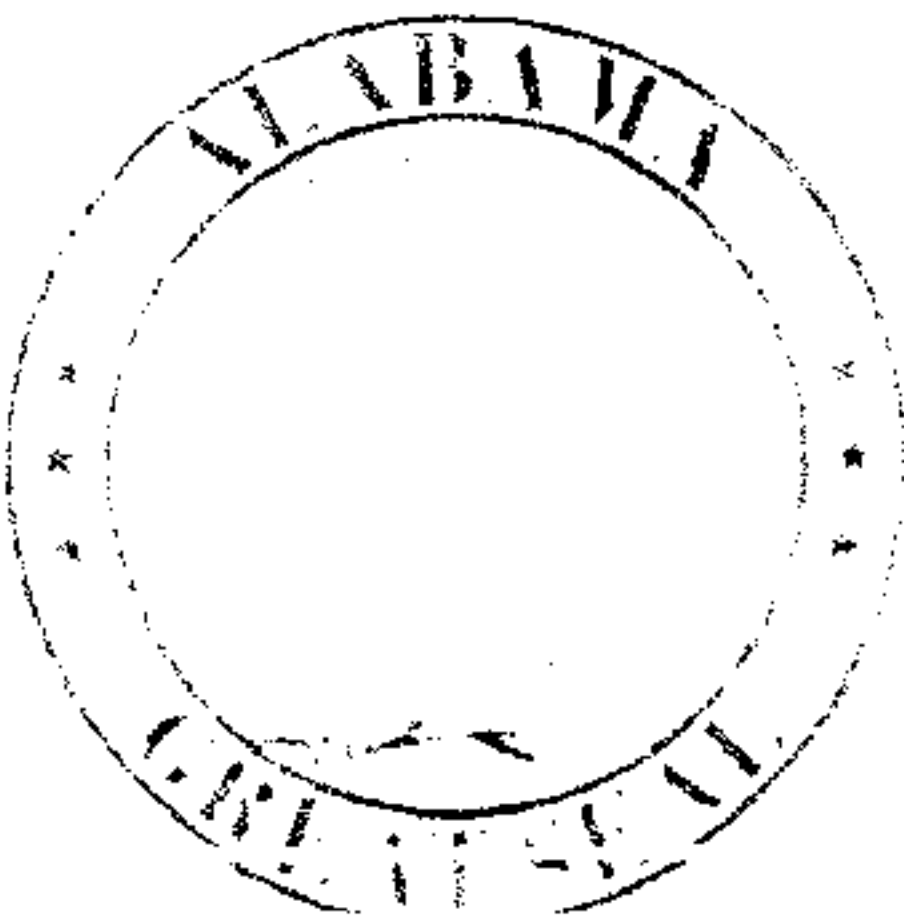
