

**ARTICLES OF INCORPORATION
OF
BROWN TECHNICAL SERVICES, INC.**

KNOW ALL MEN BY THESE PRESENTS:

That I, **Donald Brown**, the undersigned incorporator, for the purpose of forming a business corporation pursuant to the provisions of Title 10, Chapter 2B, Code of Alabama (1975), as amended, (hereinafter sometimes referred to as the *Alabama Business Corporation Act*), do hereby adopt these Articles of Incorporation, the same to constitute and become a charter for carrying on the business hereinafter specified upon the proper filing hereof pursuant to and in accordance with the laws of the State of Alabama.

**ARTICLE I
NAME**

The name of the Corporation shall be **Brown Technical Services, Inc.**

**ARTICLE II
PURPOSES**

The nature of the business and the purpose or purposes for which this Corporation is formed are as follows:

1. To provide technical consulting in the blasting, mining and construction industries.
2. To do all things necessary, desirable or expedient in the operation, management and conduct of the aforesaid business.
3. To transact any or all lawful business for which Corporations may be incorporated under the *Alabama Business Corporation Act*, as last amended, and particularly as set forth in Section 10-2B-3.01, *et seq.* thereof.

**ARTICLE III
REGISTERED OFFICE AND AGENT**

The address of the initial registered office of this Corporation shall be 460 El Camino Real, Chelsea, AL 35043, and the initial registered agent at such address is **Donald Brown**.

**ARTICLE IV
DURATION**

The duration of this Corporation shall be perpetual and unlimited, unless the Corporation is dissolved by law or otherwise terminated.

ARTICLE V CAPITAL STOCK

The total authorized capital stock of this Corporation shall be and the same is one thousand (1,000) shares of stock. All of the stock of the Corporation shall be common stock of the par value of one (\$1.00) Dollar per share.

ARTICLE VI INCORPORATORS AND DIRECTORS

ARTICLE VII MISCELLANEOUS

VOTING: Holders of common stock shall be entitled to one vote for each and every share of stock outstanding in his, her or its name, at any and all meetings of the Shareholders of the Corporation, and said stock may be voted by the Shareholders of record, either in person or by proxy.

MANAGEMENT: The business and affairs of the Corporation shall be under the management and control of a Board of Directors, said Board to consist initially of the number of persons set forth above in Article VI, and such number as may, from time to time, be fixed by the Bylaws.

SHARES NON-ASSESSABLE: The shares of capital stock in the Corporation, when fully paid for in accordance or provided by law, shall be fully paid and non-assessable; and in no case shall any Shareholder be individually liable otherwise than for the unpaid stock subscribed for by him or her.

LIEN ON SHARES: The Corporation shall have a lien on the shares of its Shareholders

for any debt or liability incurred to it by a Shareholder before a notice of transfer or levy on such shares, and shall have all the rights in respect thereto, and with respect to the enforcement of said lien as is now or may be hereafter conferred by the laws of the State of Alabama.

AMENDMENTS: The Corporation reserves the right to amend, alter, modify, change or repeal any provision contained in these Articles of Incorporation and in the manner now or hereafter provided by law, and all rights conferred upon the Officers, Directors and Shareholders of the Corporation are granted subject to this reservation.



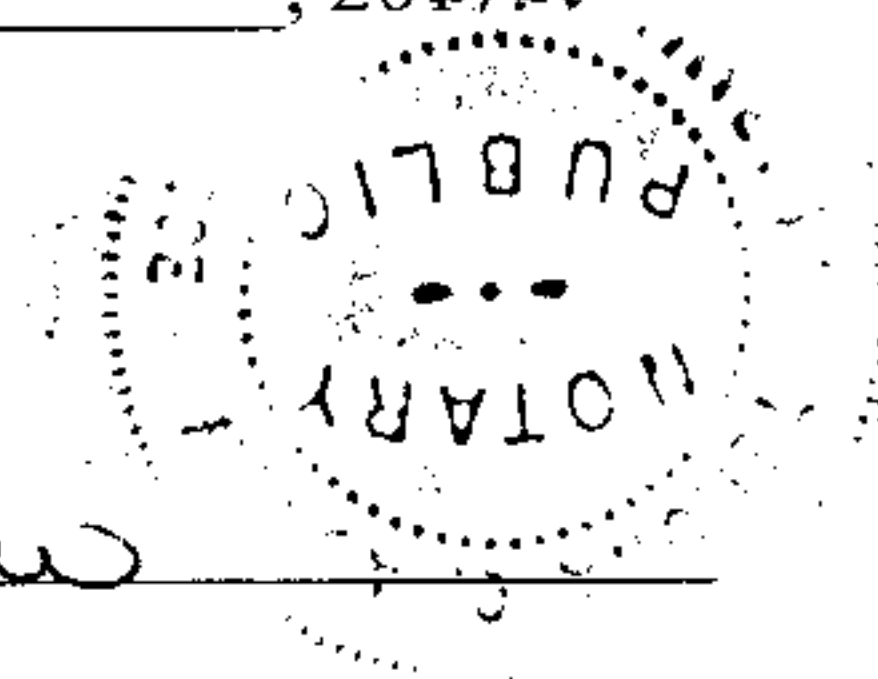
