WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

That in consideration of **Four Hundred Twenty Two Thousand Nine Hundred and 00/100 Dollars (\$422,900.00)** to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

David G. Jett, by and through his Attorney-in-Fact, Ann A. Jett,
and his wife, Ann A. Jett

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

Rachael Harvey Wood and Christopher Michael Wood

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:

Lot 121, according to the Final Plat of Greystone Farms, Milner's Crescent Sector, Phase 2, as recorded in Map Book 21, Page 33, in the Probate Office of Shelby County, Alabama.

\$401,755.00 of the proceeds come from a mortgage recorded simultaneously herewith.

Subject to: (1) 2018 ad valorem taxes not yet due and payable;
(2) all mineral and mining rights not owned by the Grantors; and
(3) all easements, rights-of-way, restrictions, covenants and encumbrances of record.
