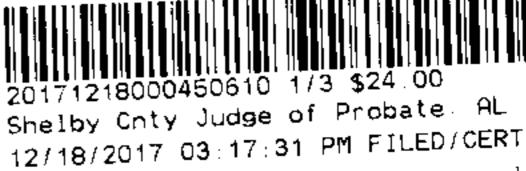

SPECIAL WARRANTY DEED

Know all men by these presents, that for and in consideration of One Hundred Forty One Thousand and No/100 Dollars (\$141,000.00) and other good and valuable consideration in hand paid to Compass Bank, an Alabama banking corporation (hereinafter referred to as "Grantor") by Jose Gilberto Hernandez Gonzalez and Jennifer Hernandez (hereinafter referred to as "Grantees") the receipt and sufficiency of which are acknowledged hereby, Grantor does by these presents grant, bargain, sell and convey unto the said Grantees, as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama, (the "Property"), together with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining:

Grantor shall not be liable to the Buyer for any prospective or speculative profits, or special, indirect or consequential damages, whether based upon contract, tort, or negligence or in any other manner arising from the transactions contemplated by this conveyance.
