The undersigned, for the purpose of forming a limited liability company pursuant to the provisions of the Alabama Limited Liability Company Law of 2014, Code of Alabama, Section 10A-5A-1.01 et seq. (the “Act”), hereby certifies as follows:

1. **NAME.** The name of the limited liability company (the “Company”) is:

2. **DURATION.** The period of duration of the Company shall be perpetual; provided, however, that the Company shall be dissolved and its affairs shall be wound up upon the occurrence of any event of dissolution specified in Section 10A-5A-7.01 of the Act.

The Company may also transact any other profitable and lawful business for which a limited liability company may be formed under the Act, but nothing contained herein shall be construed as authorizing the Company to carry on the business of banking or insurance or to act as a trust company, securities broker, securities dealer or investment advisor.


5. **INITIAL MEMBER.** The initial members of the Company are Katie Ngoc My Nguyen and Thuy Le.

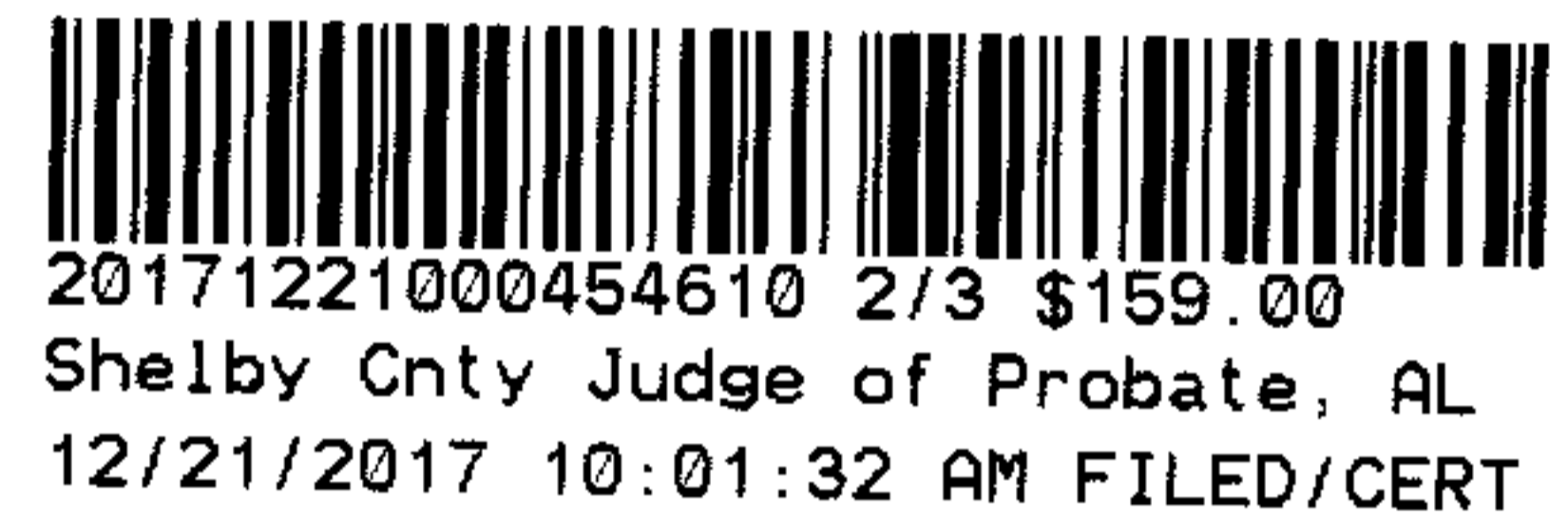

IN WITNESS WHEREOF, the undersigned, acting as the Organizer of the Company, has executed these Articles of Organization on December 21, 2017.

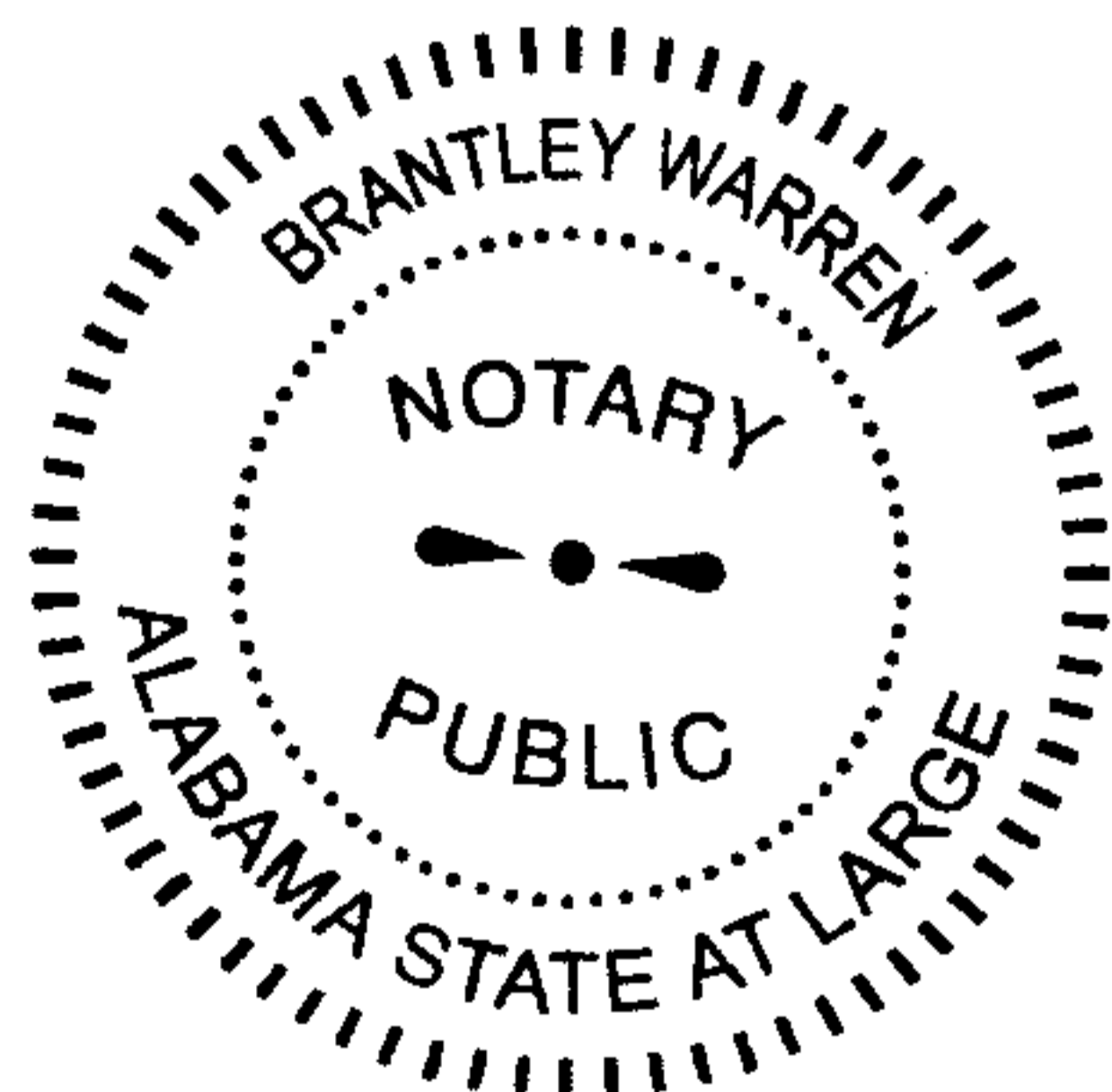



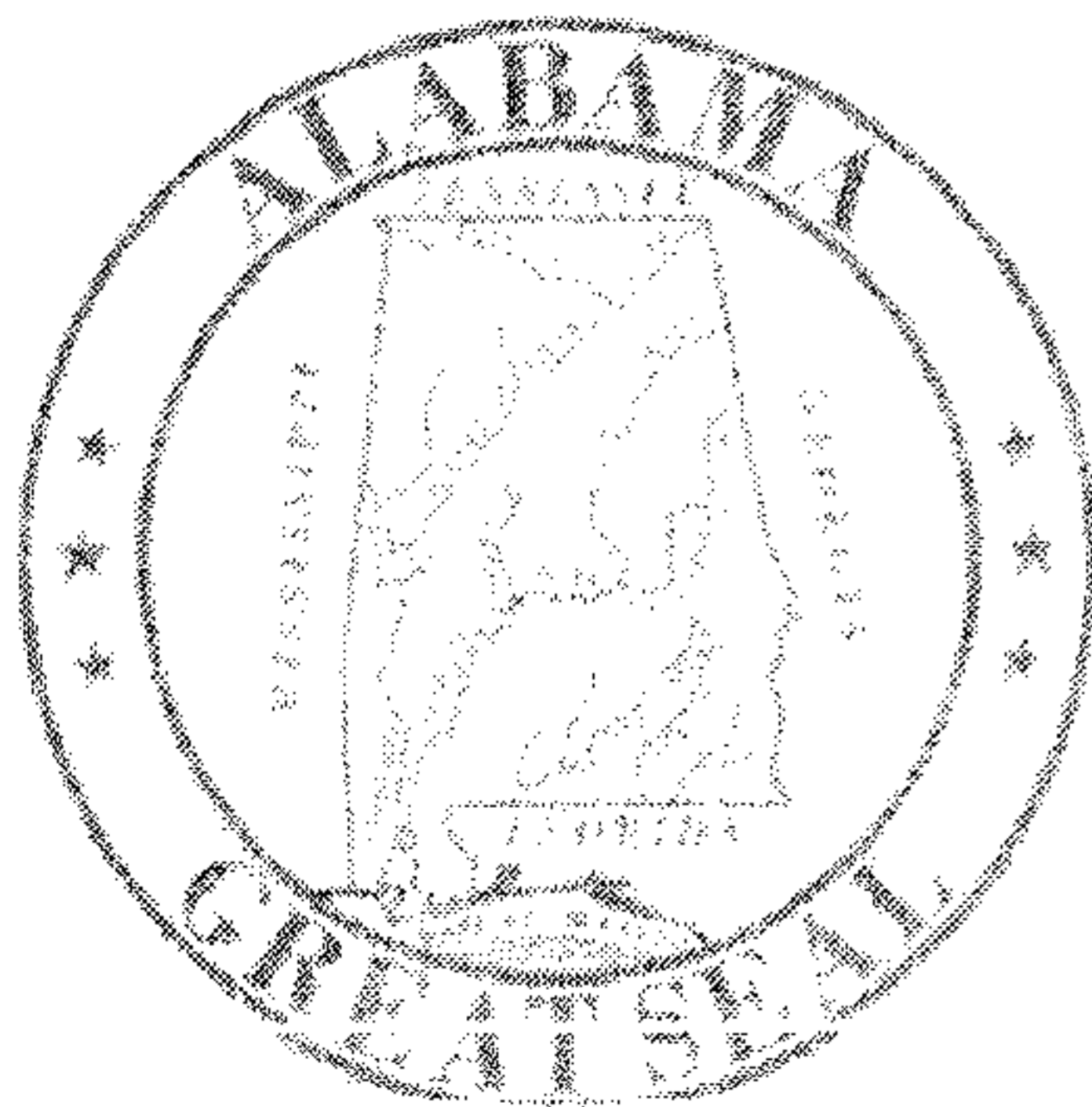
