ARTICLE I

Name

The name of the limited liability company is CM Trussville Development, LLC (the "Company").

The initial Articles of Organization of CM Trussville Development, LLC were filed in the Office of the Judge of Probate of Shelby County, Alabama in Instrument 20121106000427470 and first amended on June 24, 2013 by removing David Brandon Keith as a member by that Amendment to the Articles of Organization filed in the Office of the Judge of Probate of Shelby County, Alabama in Instrument 20130807000320610 and last amended on August 19, 2014 by removing Eugene Borgosz as a member by that Amendment to Formation/Organization filed in the Office of the Judge of Probate of Shelby County, Alabama in Instrument 20140828000271070.

ARTICLE III

Reason for Dissolution

The reason for dissolution of CM Trussville Development, LLC are as follows:

The Members of CM Trussville Development, LLC have elected by Resolution to discontinue business operations of the Company. The Company does not hold any property and there is not any property to be liquidated and distributed to the members.

ARTICLE IV

Effective Date

The effective date of the Dissolution of CM Trussville Development, LLC shall be December 21, 2017.

ARTICLE V


Indebtedness of CM Trussville Development , LLC

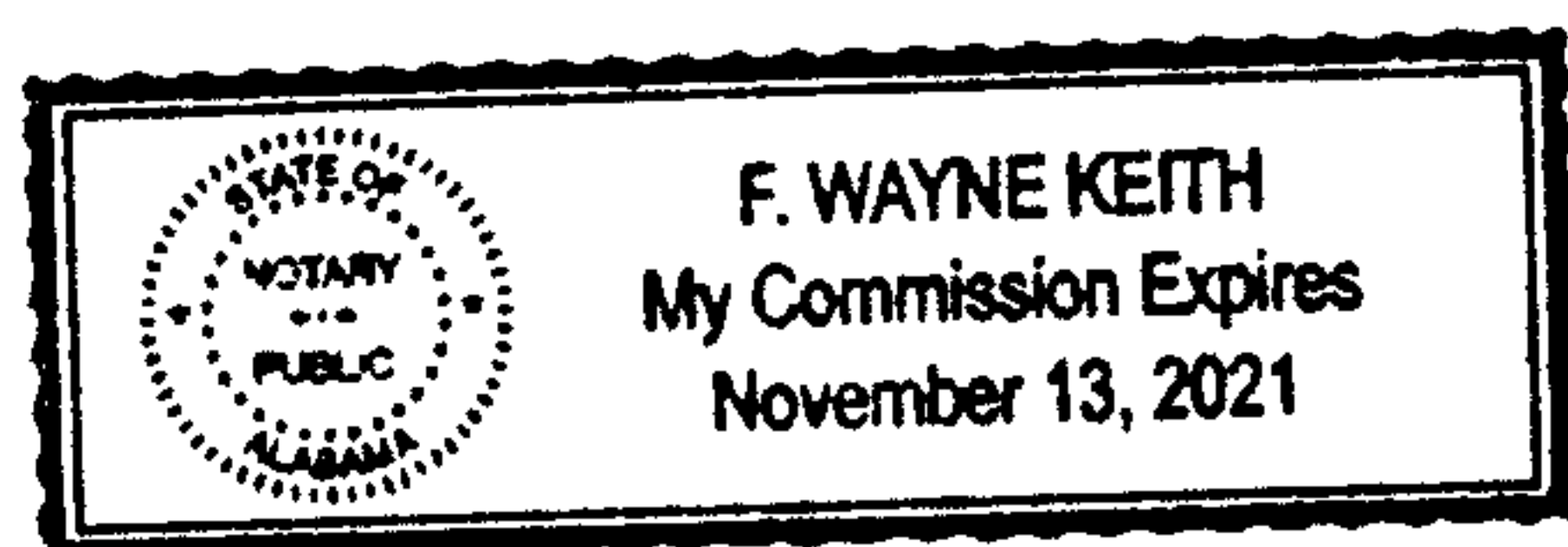


