KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of **Three Hundred Thirty-Five Thousand and 00/100 (\$335,000.00)** and other valuable considerations to the undersigned **GRANTOR(S), DAVID RALPH CROWE and MARY HELEN CROWE, HUSBAND AND WIFE**, (hereinafter referred to as **GRANTORS**), in hand paid by the **GRANTEE(S)** herein, the receipt of which is hereby acknowledged, the said **GRANTOR(S)** does by these presents **GRANT, BARGAIN, SELL and CONVEY** unto **KRISTOHPER AREN MACON and BRITTNEY LEAH MACON**, hereinafter referred to as **GRANTEE(S)**, for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in County of Shelby State of Alabama, to-wit:

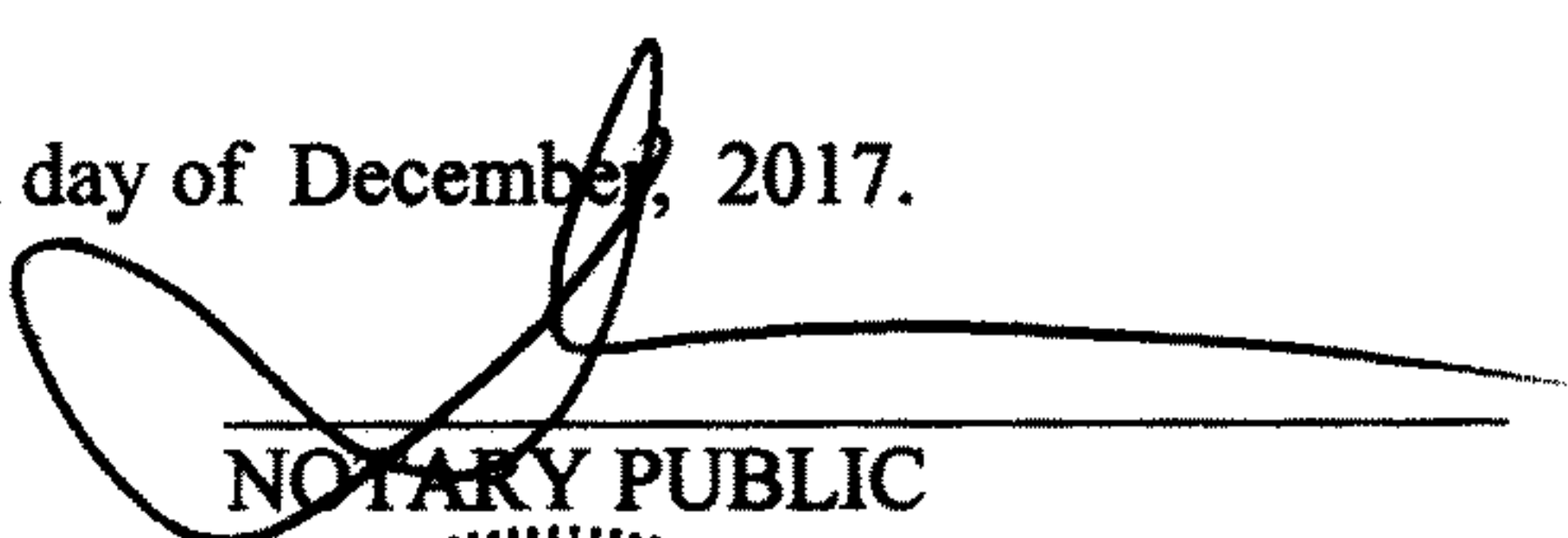

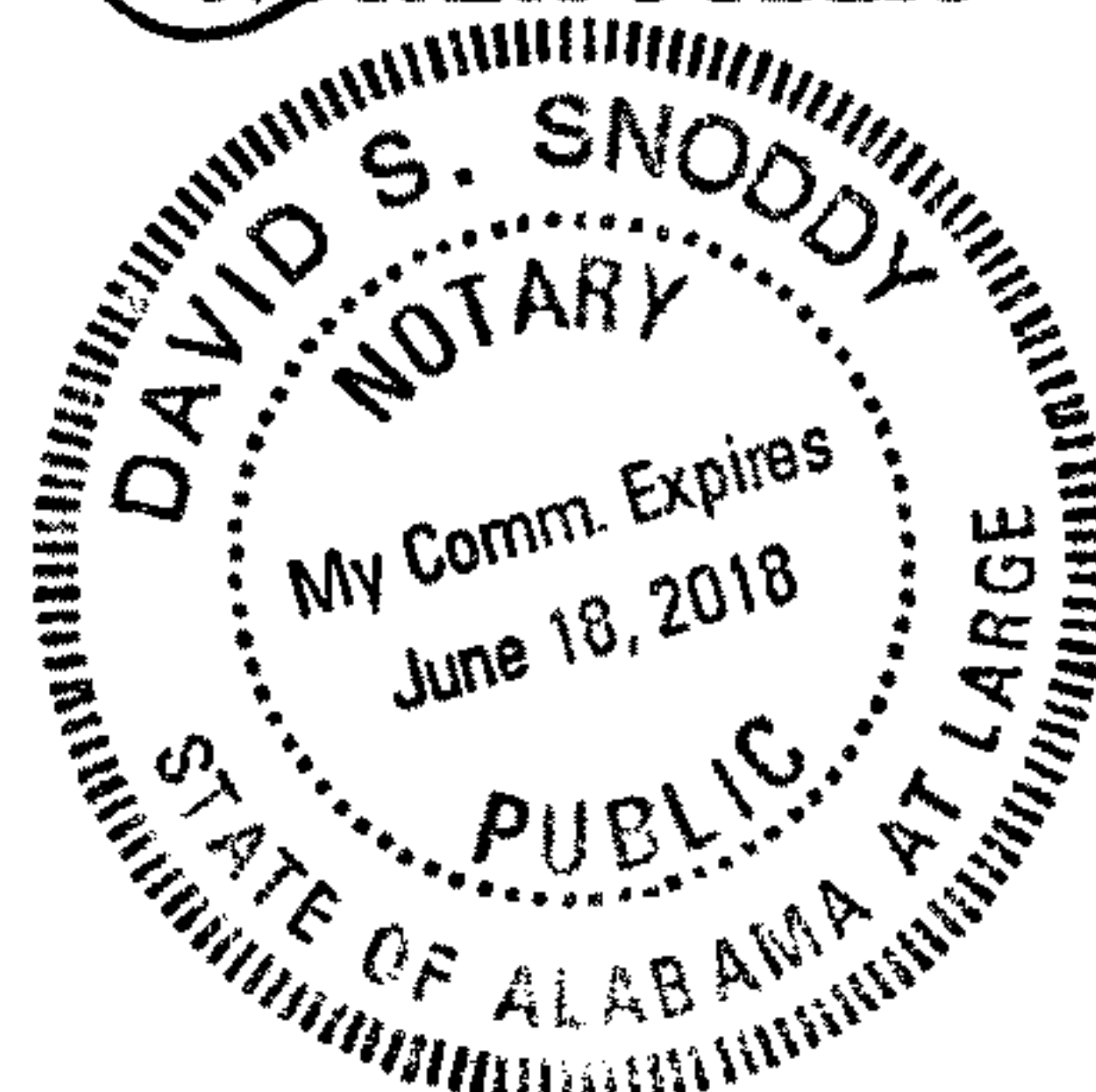
