FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 19th day of September, 2014, Mark Lewis, a single man, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for Platinum Mortgage, Inc., an Alabama Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20140924000299490, said mortgage having subsequently been transferred and assigned to Pingora Loan Servicing, LLC, by instrument recorded in Instrument Number 20170619000217520, in the aforesaid Probate Office ("Transferee"); and



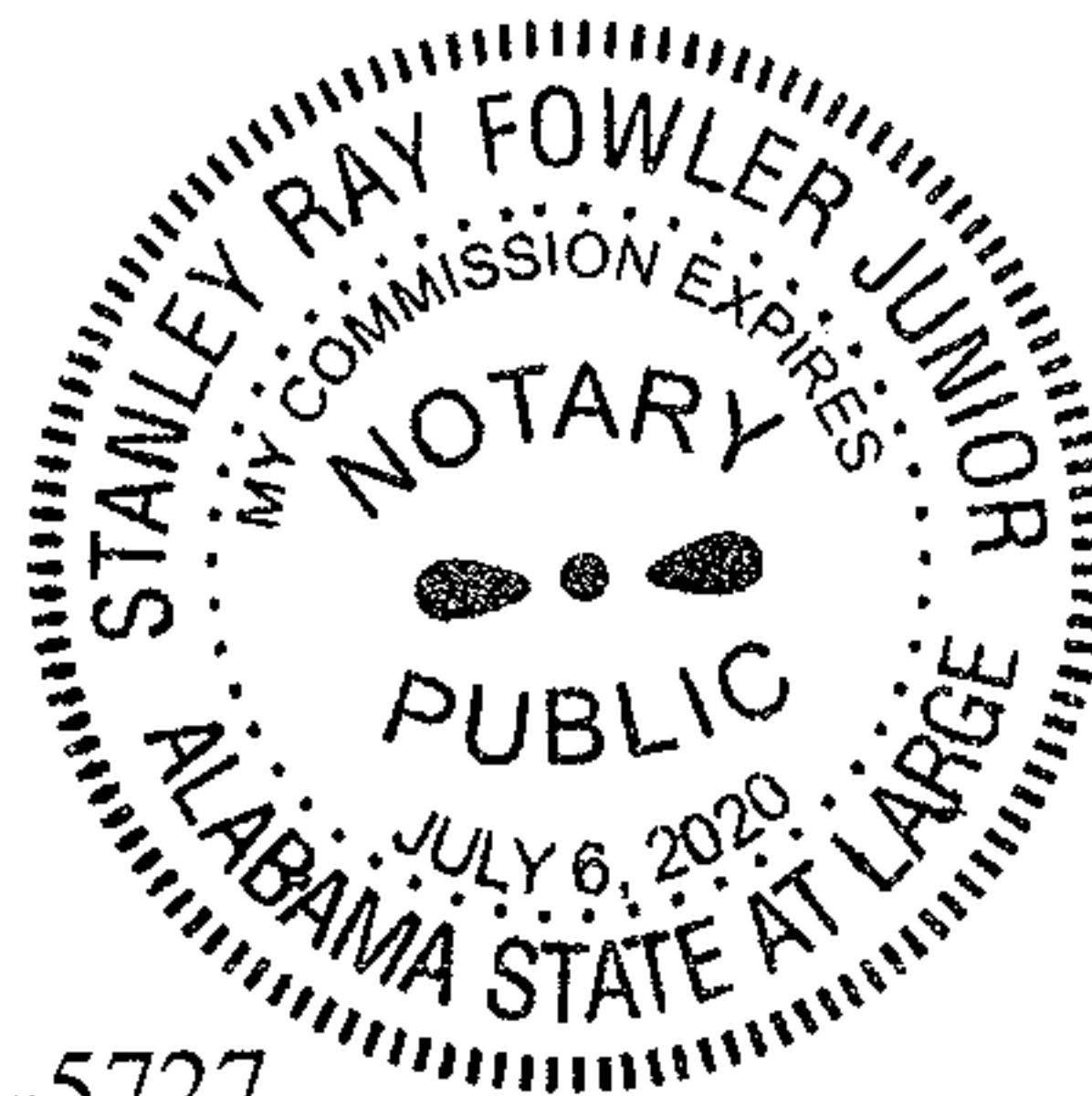
