Lot 20, according to the Survey of Marengo Sector One, as recorded in Map Book 22, Page 123, in the Probate Office of Shelby County, Alabama

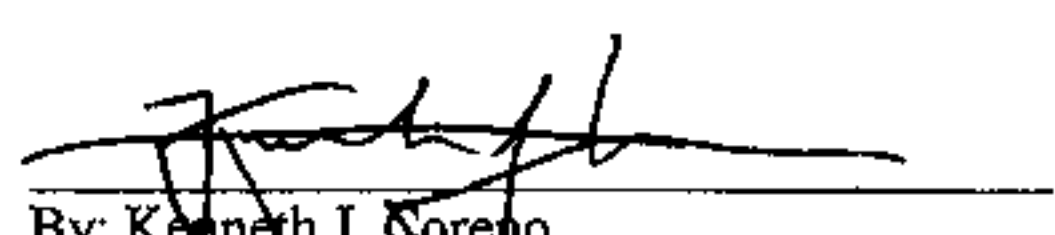

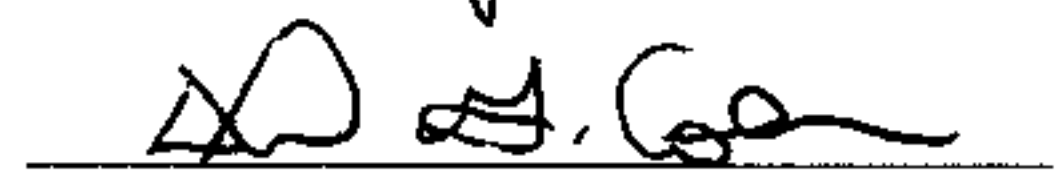
\$74,000.00 of the purchase price was paid from the proceeds of a purchase money mortgage closed simultaneously herewith.

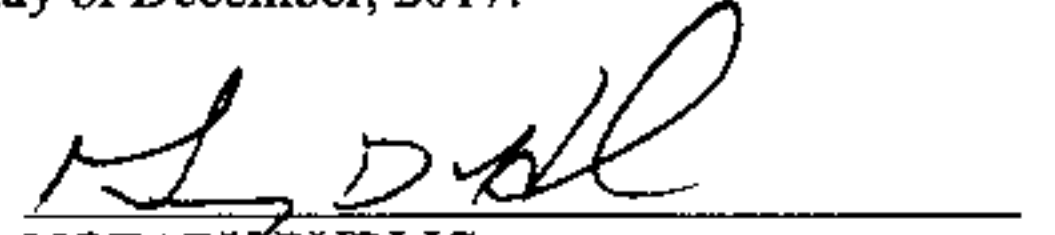
