That in consideration of the sum of **Two Hundred Four Thousand and 00/100 Dollars (\$204,000.00)** to the undersigned grantor in hand paid by the GRANTEES herein, the receipt whereof is hereby acknowledged, I,

(herein referred to as GRANTOR, whether one or more) do grant, bargain, sell and convey unto

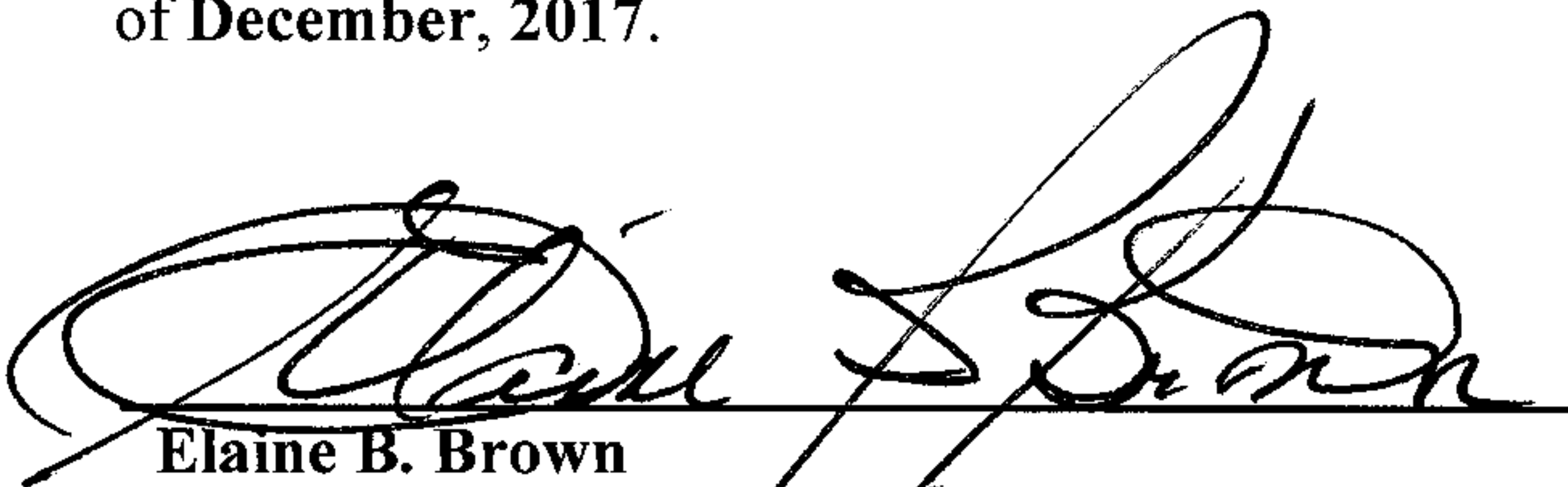
