On this January 3, 2018, That for and in consideration of ONE HUNDRED TWO THOUSAND SEVEN HUNDRED AND NO/100 (\$102,700.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTORS KELLY O. HOUSE, a married person, (herein referred to as "Grantor"), in hand paid by the Grantee herein, the receipt whereof is hereby acknowledged, the Grantor does hereby give, grant, bargain, sell and convey unto the GRANTEE, ANDERSON K. WHITCOMB, (herein referred to as "Grantee"), Grantee's heirs and assigns, any and all of the respective Grantor's interest in the following-described Real Estate situated in, SHELBY COUNTY, ALABAMA, to wit:

Unit 311, according to the Survey of Cambrian Wood Condominium, as recorded in Map Book 6, Page 62 in the Probate Office of Shelby County, Alabama, being situated in Shelby County, Alabama, and also as established by Declaration of Condominium, By-Laws and Amendments thereto, as recorded in Misc. Book 12, Page 87, and amended by Misc. Book 13, Page 2; Misc. Book 13, Page 4; Misc. Book 13, Page 344; Misc. Book 52, Page 318 and Instrument No. 1997-39374, in the Probate Office of Shelby County, Alabama; and in the By-Laws of Cambrian Wood Condominium, Inc., recorded in Misc. The purchase of the herein described real property is being financed in whole or in part by the proceeds of a purchase money mortgage being executed simultaneously herewith.


