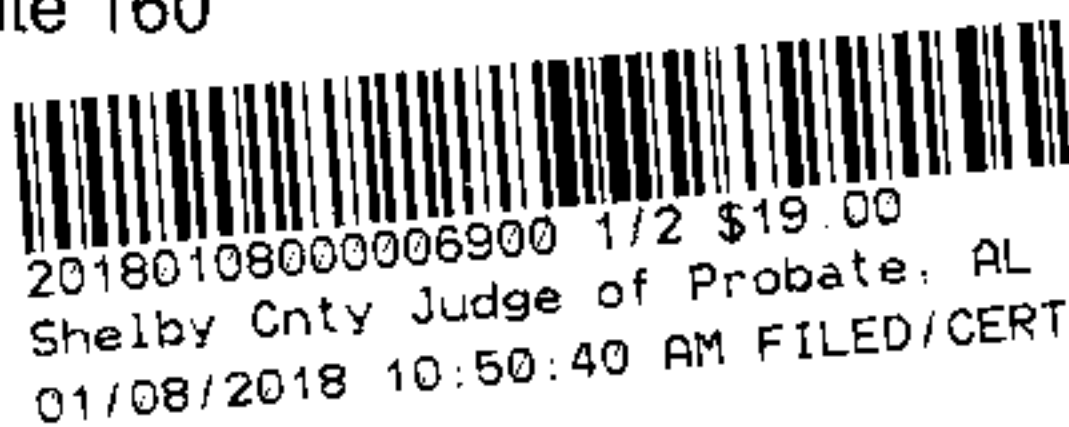

JOINT SURVIVORSHIP DEED

KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of **Three Hundred Fifty-Four Thousand Seventy-Two and 50/100 (\$354,072.50)**, and other good and valuable consideration, this day in hand paid to the undersigned **Scotch Homes & Land Development Group, Inc., an Alabama corporation** (hereinafter referred to as GRANTOR), in hand paid by the GRANTEES herein, the receipt whereof is hereby acknowledged, the GRANTOR does hereby give, grant, bargain, sell and convey unto the GRANTEES, **Jason D. Kirkes and Jackie Kirkes**, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of **Shelby**, State of Alabama, to-wit:

Lot 145, according to the Survey of Willow Branch Second Sector, as recorded in Map Book 48, Page 35, in the Probate Office of Shelby County, Alabama.

Subject To:

Existing covenants and restrictions, easements, building lines and limitations of record.


\$365,756.00 of the consideration was paid from the proceeds of a mortgage loan closed simultaneously herewith.

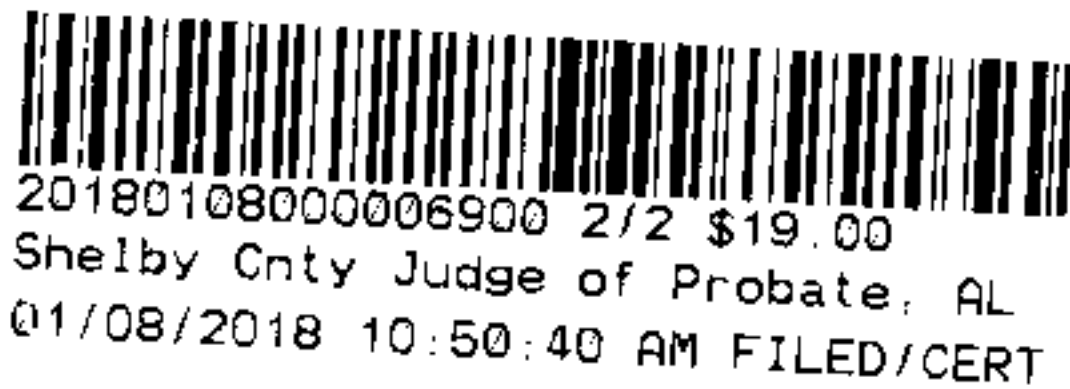
