**ARTICLES OF AMENDMENT TO THE ARTICLES
OF INCORPORATION OF CLEAR SOLUTIONS, INC.**

Pursuant to the provisions of Section 10A-2-10.06 of the Code of Alabama, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation, effective the 1st day of January, 2018.

Article I of the Articles of Incorporation is hereby amended in its entirety so that as amended, it reads in full as follows:

"ARTICLE I

The name of the corporation shall be ENG AV, INC.

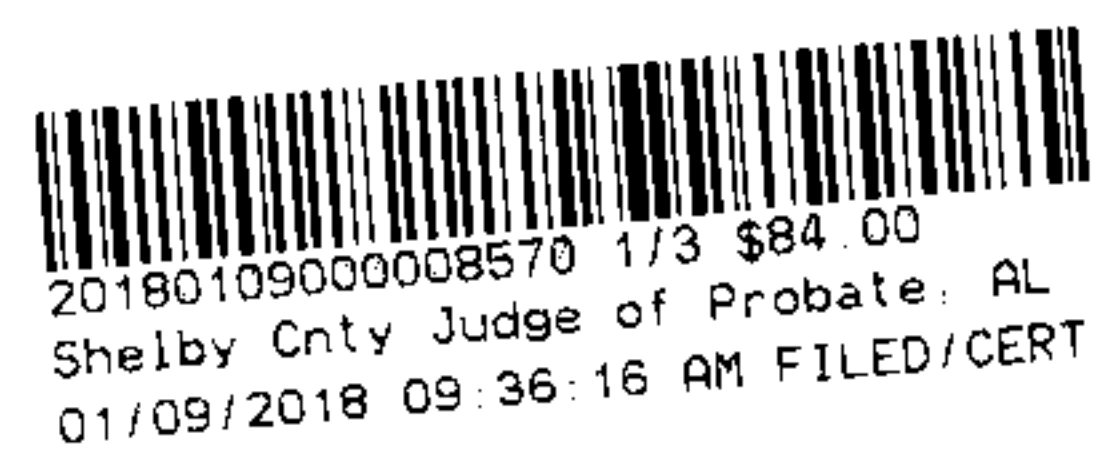
