

**ARTICLES OF ORGANIZATION  
OF

The undersigned, for the purpose of forming a limited liability company pursuant to the provisions of the Alabama Limited Liability Company Law of 2014, Code of Alabama, Section 10A-5A-1.01 et seq. (the "Act"), hereby certifies as follows:

1. **NAME.** The name of the limited liability company (the "Company") is:

**Lab Frequencies Leasing, LLC**

2. **DURATION.** The period of duration of the Company shall be perpetual; provided, however, that the Company shall be dissolved and its affairs shall be wound up upon the occurrence of any event of dissolution specified in Section 10A-5A-7.01 of the Act.

3. **PURPOSES.** The Company has been organized primarily for the purposes including but not limited to leasing wave frequency devices and all other services allowable under the laws of the State of Alabama. The Company may also transact any other profitable and lawful business for which a limited liability company may be formed under the Act, but nothing contained herein shall be construed as authorizing the Company to carry on the business of banking or insurance or to act as a trust company, securities broker, securities dealer or investment advisor.




