That, in consideration of \$106,100.00, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor, in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, Adam C. Brannan and Katie Brannan, a married couple (the "Grantor", whether one or more), whose mailing address is 3381 Morgan Rd, Bessemer, AL 35022, do hereby grant, bargain, sell, and convey unto Dustin Brook Pruitt and Olga Pruitt (the "Grantees"), whose mailing address is 182 Bonnieville Drive, Calera, AL 35040, as joint tenants with right of survivorship, the following-described real estate situated in Shelby County, Alabama, the address of which is 182 Bonnieville Drive, Calera, AL 35040; to-wit:

Lot 1, according to the Survey of Willow Cove, Phase 1, as recorded in Map Book 23, Page 75, in the Probate Office of Shelby County, Alabama.

Subject to:

- (1) ad valorem taxes for the current year and subsequent years;
- (2) restrictions, reservations, conditions, and easements of record, if any; and
- (3) any minerals or mineral rights leased, granted, or retained by prior owners.

TO HAVE AND TO HOLD unto the said Grantees for and during their joint lives as joint tenants, and upon the death of either of them, then to the survivor in fee simple, and to the heirs and assigns of such survivor forever, together with every contingent remainder and right of reversion.
