

FIRST AMENDMENT TO MORTGAGE AND SECURITY AGREEMENT

THIS FIRST AMENDMENT TO MORTGAGE AND SECURITY AGREEMENT (the "Amendment"), is made and entered into as of December 11, 2017, among TBR, INC., an Alabama corporation (the "Borrower"), THORNTON I-65 HOLDINGS, LLC, an Alabama limited liability company (the "Accommodation Mortgagor"), both of whose address is c/o Thornton, Inc., 5300 Cahaba River Road, Suite 200, Birmingham, Alabama 35243, Attention: Mr. William L. Thornton III (Borrower and Accommodation Mortgagor hereinafter referred to collectively as the "Mortgagors" and each singularly as a "Mortgagor"), and SERVISFIRST BANK, an Alabama banking corporation, whose address is 2500 Woodcrest Place, Birmingham, Alabama 35209, Attention: Clark Zinsmeister (the "Bank"). Capitalized terms used herein but not defined shall have the meaning ascribed to such terms in the Mortgage (as hereinafter defined).

WHEREAS, Mortgagors executed and delivered in favor of Bank that certain Mortgage and Security Agreement dated as of March 8, 2017, which instrument was recorded (i) in the Office of the Judge of Probate of Jefferson County, Alabama on March 13, 2017, as Instrument No. 2017023831, and (ii) in the Office of the Judge of Probate of Shelby County, Alabama on March 10, 2017, as Instrument No. 20170310000083200 (the "Mortgage"); and

WHEREAS, pursuant to that certain First Amendment to Credit Agreement of even date herewith among Mortgagors and Bank (the "First Credit Agreement Amendment"), Bank has agreed to extend additional credit to Borrower in the principal amount of \$350,000.00 (the "Loan A Increase"), and in connection therewith, Mortgagors and Bank desire to amend the Mortgage in order to increase the amount secured thereby from \$1,850,000.00 to \$2,200,000.00, as hereinafter provided.

NOW, THEREFORE, in consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Borrower and Bank hereby agree that the Mortgage is amended as follows:

1. The Mortgage is hereby amended by deleting the second paragraph thereof and by substituting the following in lieu thereof:

WHEREAS, pursuant to the provisions of the Credit Agreement, Bank extended to Borrower the Loan A in the maximum principal amount of Two Million Two Hundred Thousand and 00/100 Dollars (\$2,200,000.00), such indebtedness being represented by the Note A; and

- 2. The Mortgage is hereby amended by increasing the principal indebtedness secured thereby from \$1,850,000.00 to \$2,200,000.00 (viz., an increase of \$350,000.00).
- 3. To secure the Obligations, each Mortgagor does hereby convey, mortgage and warrant, grant, bargain, sell, assign, transfer, pledge and set over, re-convey, re-mortgage and rewarrant, re-grant, re-bargain, re-sell, re-assign, re-transfer, re-pledge and re-set over to Bank, its successors and assigns, all of such Mortgagor's Interst in and to the Mortgaged Property.
- 4. Mortgage tax is being paid upon the recording of this Amendment in the amount of \$525.00 (viz., \$1.50 per \$1,000.00 (or portion thereof) of the amount of the Loan A Increase).
- 5. Except as hereinafter expressly amended, the terms of the Mortgage are hereby ratified and affirmed.
- 6. In the event of any conflict between the provisions of the Mortgage, as hereby amended, and the provisions of the Credit Agreement (as amended by the First Credit Agreement Amendment), the provisions most favorable to Bank shall control.
