Know All Men by These Presents: That in consideration of **Three Hundred Ninety-One Thousand Six Hundred Seventy-Five and no/100 Dollars (\$391,675.00)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt where is acknowledged, **DONOVAN BUILDERS, LLC** (herein referred to as Grantor), grant, bargain, sell and convey unto **JAMES S. 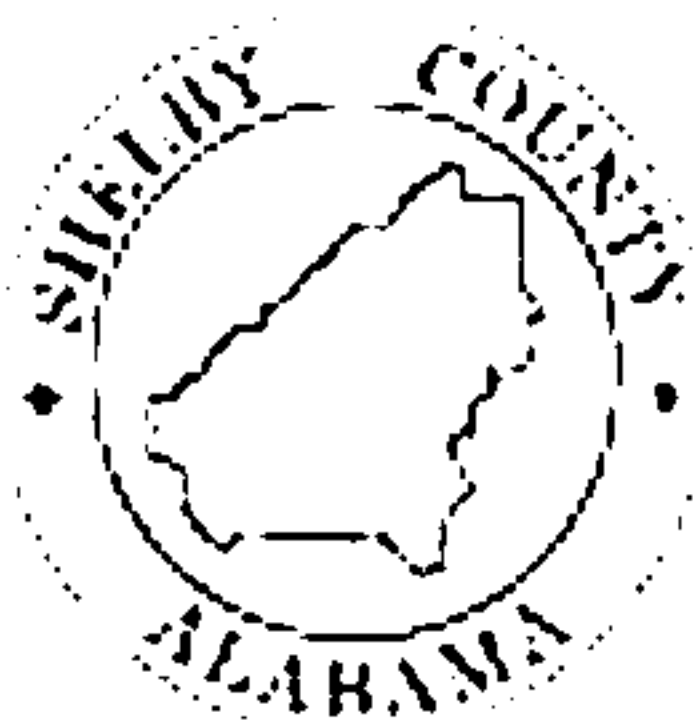
