Ad valorem taxes for 2018 and subsequent years not yet due and payable until October 1, 2018.

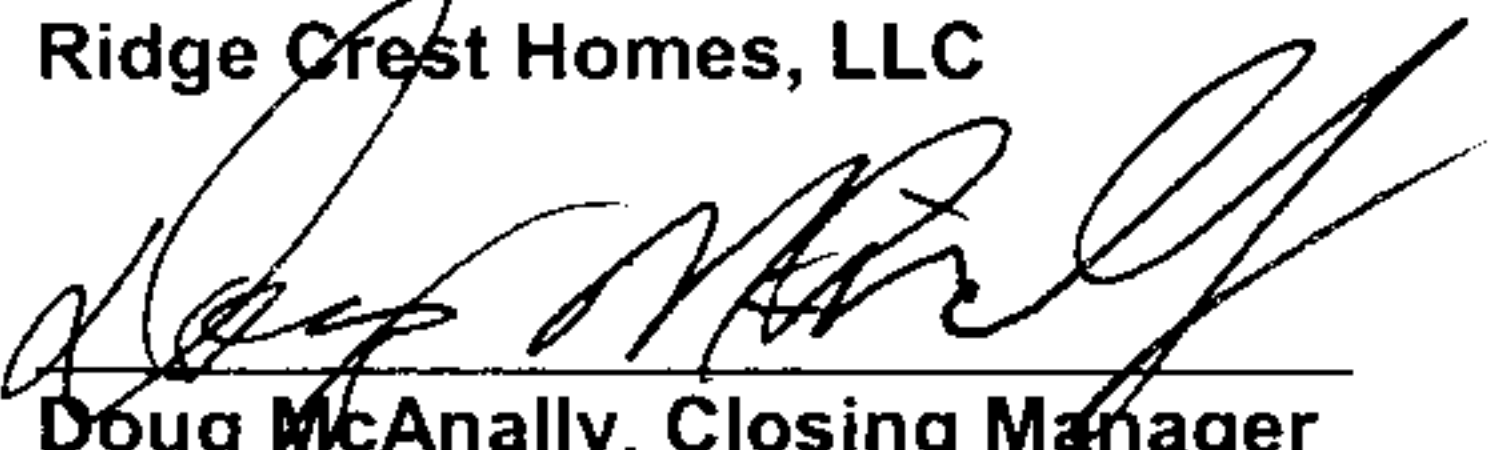

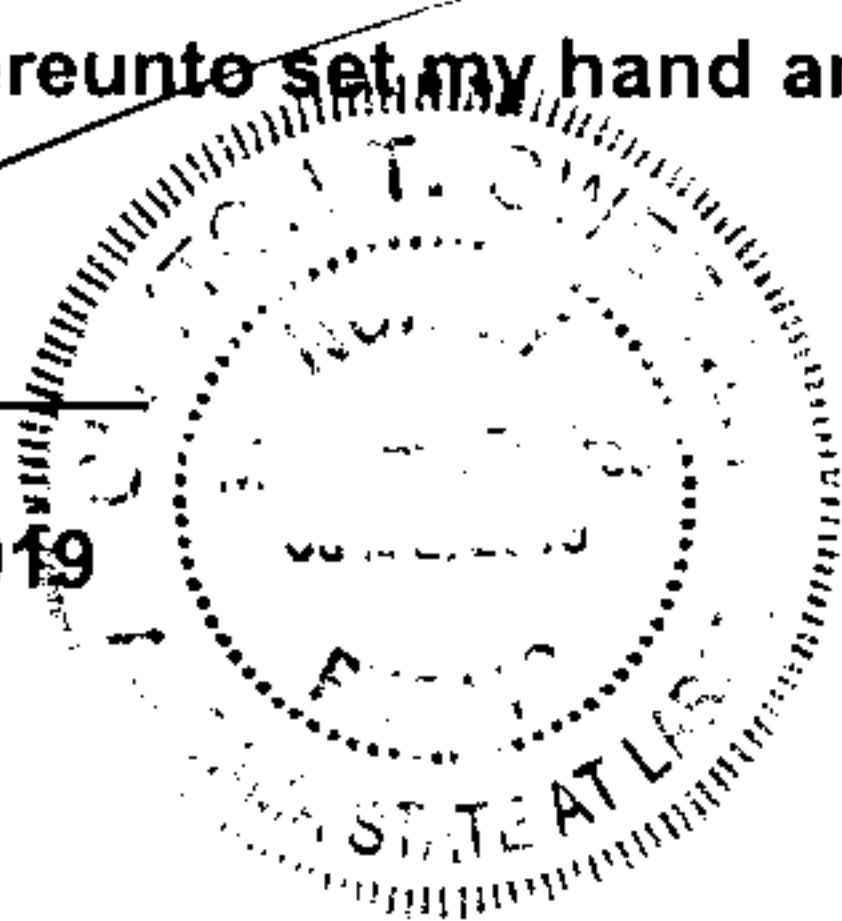
