WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

That in consideration of **Three Hundred Seventy Five Thousand and 00/100 Dollars (\$375,000.00)** to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

Charles Reed, II and Miriam Elizabeth Reed

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:

Lot 43, according to the Survey of Meadowridge, as recorded in Map Book 11, pages 40 A & B, in the Probate Office of Shelby County, Alabama.



\$345,000.00 of the proceeds come from a mortgage recorded simultaneously herewith.

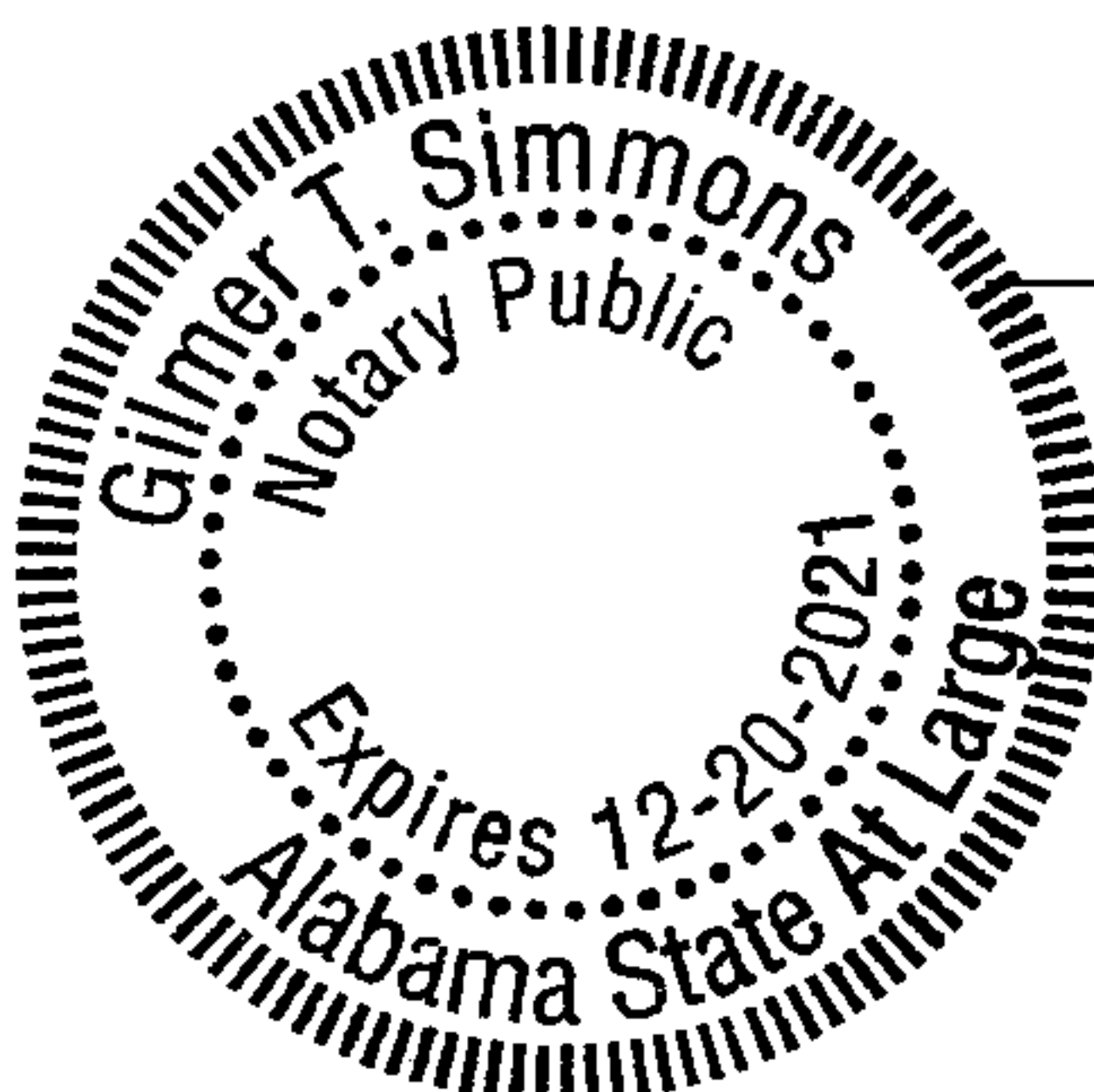

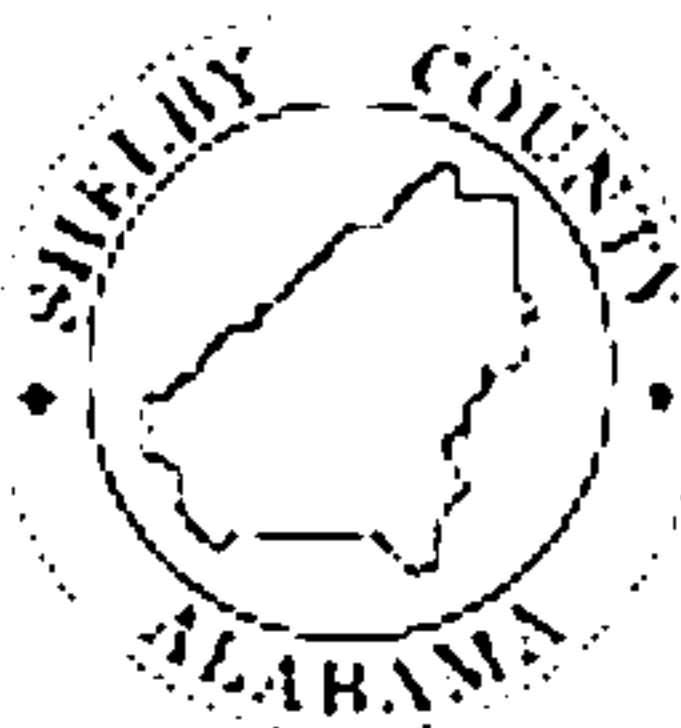
