KNOW ALL MEN BY THESE PRESENTS: That Odis Lee Carden and April D. Carden, as joint tenants with right of survivorship did to-wit, January 21, 2010, execute a mortgage to Mortgage Electronics Registration Systems, Inc., as nominee for First Guaranty Mortgage Corporation, which mortgage is recorded in Instrument # 201002110000424490 on February 11, 2010, and modified in agreement recorded January 14, 2016 at Instrument # 20160114000014590, in the Office of the Judge of Probate of Shelby County, Alabama, and secured indebtedness having been transferred or assigned to Nationstar Mortgage LLC as reflected by instrument recorded in Instrument #, 20140710000208670 of the same Office.

WHEREAS, the highest and best bid for cash obtained for the property described in the aforementioned mortgage was the bid of Nationstar Mortgage LLC, in the amount of \$97,786.76 which sum the said Nationstar Mortgage LLC offered to credit on the indebtedness secured by said mortgage, and said property was thereupon sold to the said Nationstar Mortgage LLC.

From this beginning point continue south along the east boundary of said 1/4-1/4 section for a distance of 105.0 feet; thence turn an angle of 88 degrees, 50 minutes to the right and proceed West for a distance of 210.0 feet; thence turn an angle of 91 degrees 10 minutes to the right and proceed North for a distance of 105.0 feet; thence turn an angle of 88 degrees 50 minutes to the right and proceed East for a distance of 210.0 feet to the point of beginning. 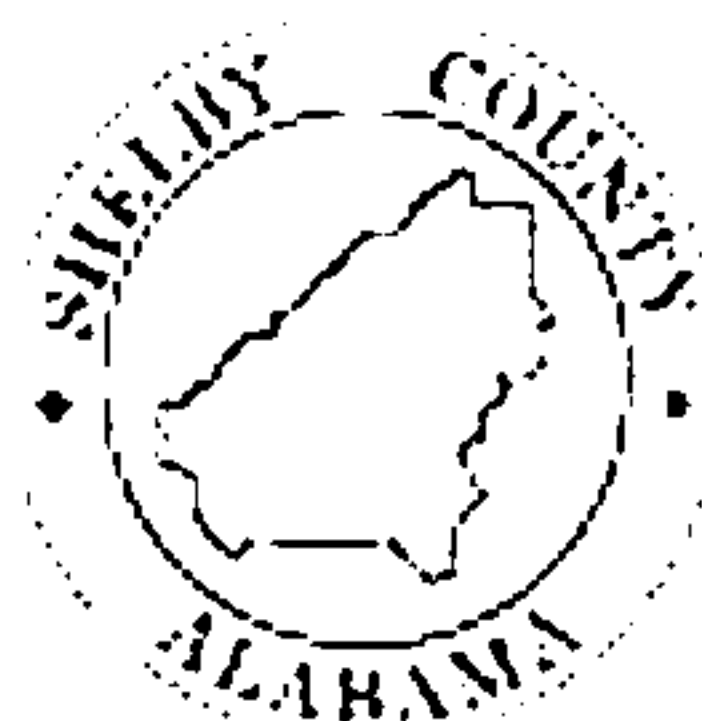
