## **ORDER**

This matter came before the Court on the PETITION FOR LETTERS OF SPECIAL CONSERVATORSHIP FOR A SINGLE TRANSACTION UNDER §26-2A-137 filed by Tammy Schoel, as Guardian for Lindsay Jo Vinsant, together with the exhibits attached thereto. Upon consideration of the foregoing, the Court finds that there is a need for the appointment of a Special Conservator for a Single Transaction under §26-2A-137 as set forth in said petition.

## Accordingly, it is hereby ORDERED, ADJUDGED AND DECREED as follows:

- A. Tammy Schoel shall be appointed Special Conservator upon the Court's issuance of Letters of Special Conservatorship to Tammy Schoel for Lindsay Jo Vinsant, an incapacitated person, for the limited purpose of executing the Quitclaim Deed attached hereto for the single transaction in conveying whatever limited interest Lindsay Jo Vinsant may have in the real property in Shelby County described therein to Colbert Frederick Clark or his assigns.
- B. Tammy Schoel, as Special Conservator, is hereby authorized to execute on behalf of Lindsay Jo Vinsant, an incapacitated person, any further documents which may be required to clearly establish title to said Shelby County property in the name of Colby Frederick Clark or his assigns.
- C. Tammy Schoel shall report back to the Court that the Quitclaim Deed attached hereto has been duly executed by her in her representative capacity as Special Conservator and delivered to Colby Frederick Clark or his designated representative, and all requirements have been met to clearly establish title to the Shelby County property in the name of Colby Frederick Clark or his assigns.
- D. Upon satisfaction of the provisions of paragraphs (a)-(c) above, the Special Conservatorship shall cease and Tammy Schoel shall be discharged as Special Conservator for Lindsay Jo Vinsant, an incapacitated person, by further order of this Court.

Costs of Court are hereby taxed against the Estate. E.



The NW 1/4 of the SE 1/4, the NE 1/4 of the SE 1/4, the SW 1/4 of the SE 1/4, the SE 1/4 of the SE 1/4, all in Section 28, Township 18 South, Range 1 East, LESS AND EXCEPT a parcel containing 3 acres more or less of land in the Southwest corner of the NW 1/4 of the SE 1/4 of said Section 28. Said parcel has equal distances on each side.

#### Also:
