That in consideration of the sum of **One Hundred Fifty Eight Thousand Dollars and No Cents (\$158,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Anthony A. Moore and Shannon Moore**, husband and wife (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Brian Keith Fulton and Chelsey Burhus**, (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit:

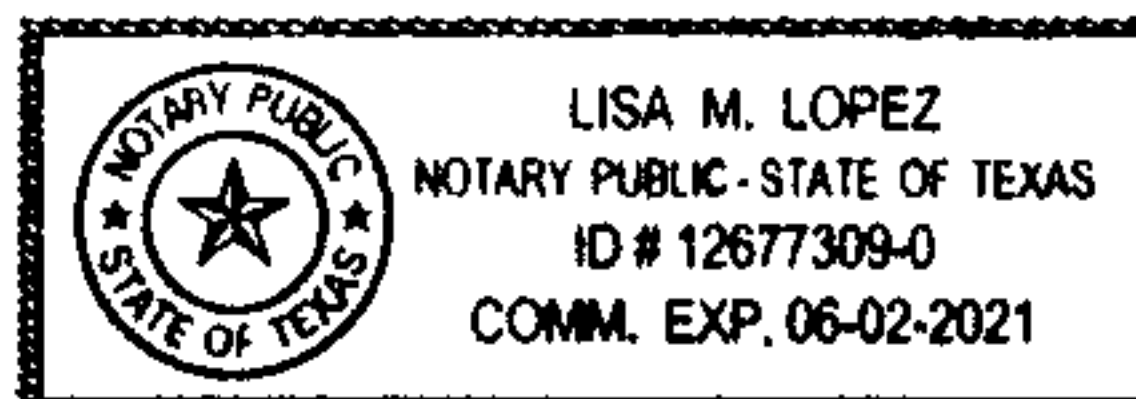
