(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

\$191,200.00 of the proceeds come from a mortgage recorded simultaneously herewith.

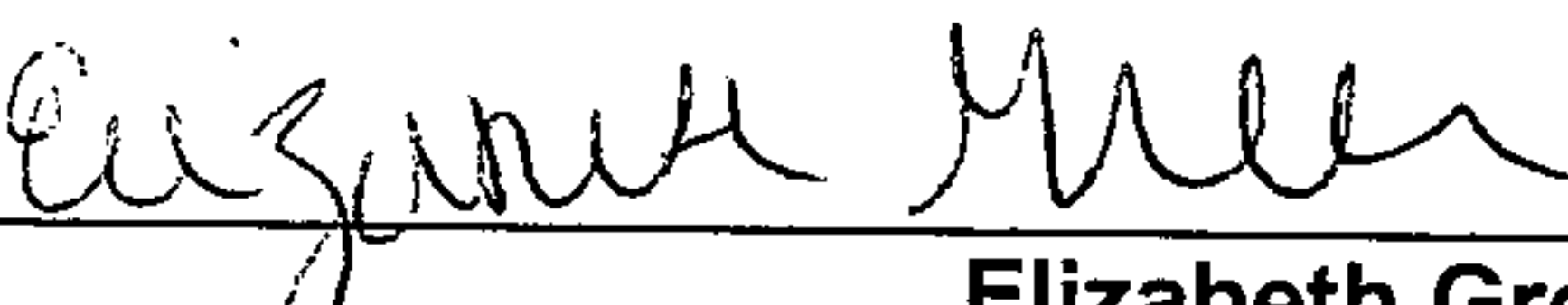
Subject to:

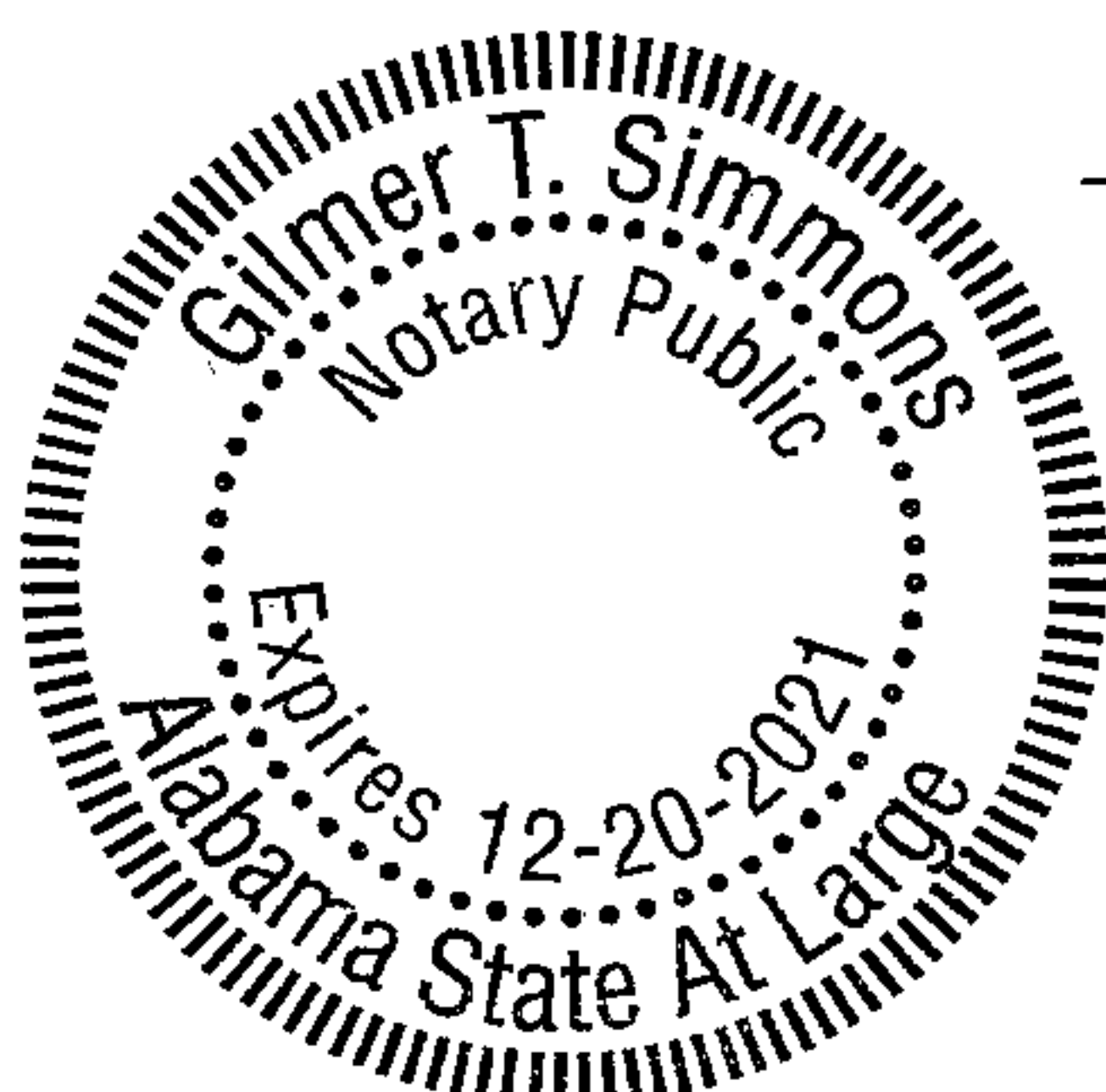

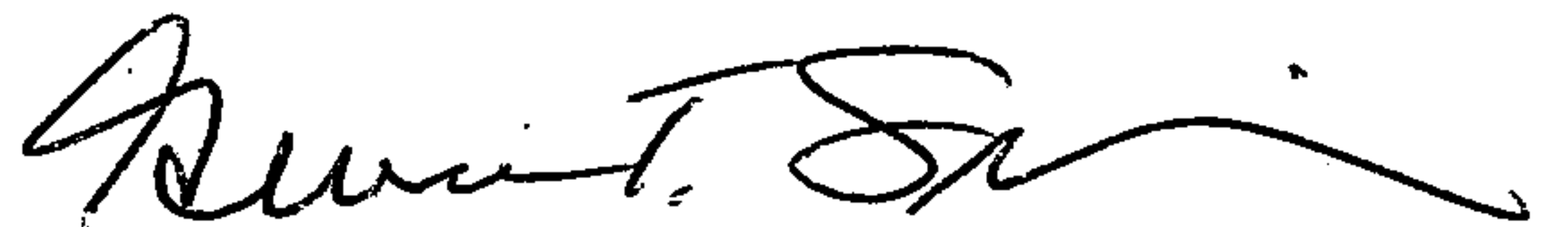

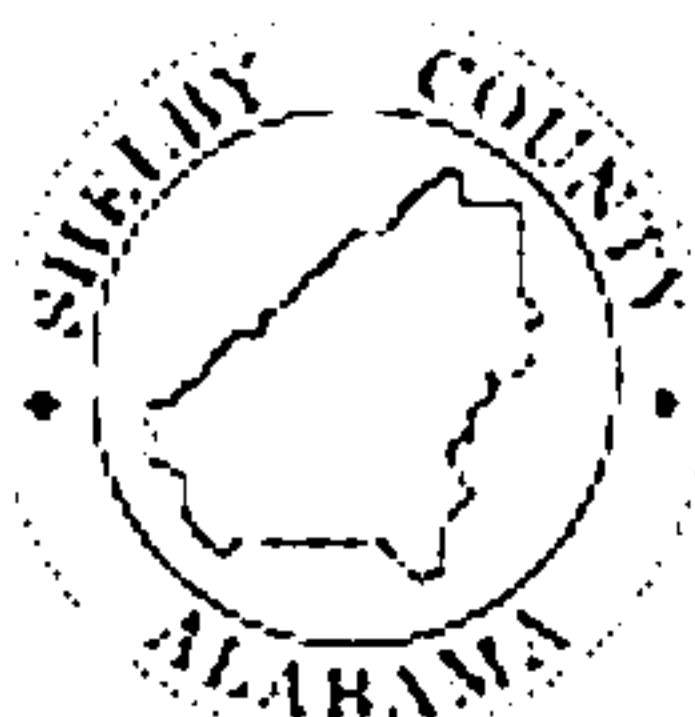
