WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

Jonathan David Prince and Annika Prince

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:



\$286,500.00 of the proceeds come from a mortgage recorded simultaneously herewith.




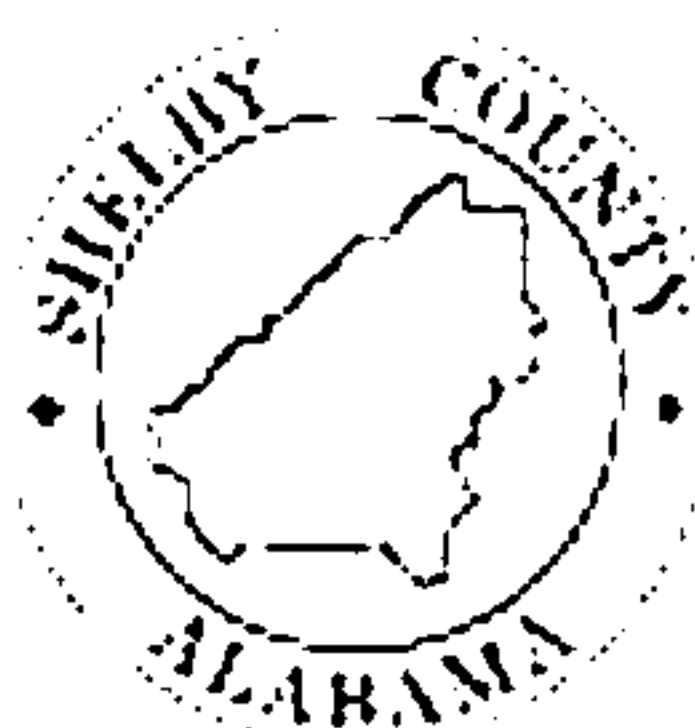
