

ARTICLES OF ORGANIZATION OF LEGACY BUILDERS GROUP LLC

Pursuant to the Provisions of the revised Alabama Limited Liability Company Law, the undersigned hereby adopts the following Limited Liability Company Articles of Organization, also known as Certificate of Formation.

- 1. The name of the limited liability company is Legacy Builders Group, LLC, hereinafter referred to in these Articles of Organization as the "Company."
