


## LIMITED POWER OF ATTORNEY TO EXECUTE DOCUMENTS

FEDERAL NATIONAL MORTGAGE ASSOCIATION A/K/A FANNIE MAE, a corporation organized and existing under the laws of the United States of America, having an office for the conduct of business at 14221 Dallas Parkway, Suite 1000, Dallas, Texas 75254, constitutes and appoints Sirote & Permutt, PC, organized under the laws of the state of Alabama, with an office for the conduct of business at 2311 Highland Avenue South, Birmingham, Alabama 35205 as its true and lawful Attorney-in-Fact, and in its name, place, and stead and for its use and benefits, to do all things, execute, endorse, and acknowledge all documents customary and reasonably necessary and appropriate for the escrow or closing of sales and the conveyance of real properties or co-op properties owned by Fannie Mae in the state of Alabama. Such powers shall include, but are not limited to, the following:

- 1. Deeds transferring the real property and improvements owned by Fannie Mae;
- 2. Settlement/Closing Statements;
- 3. Affidavits and Indemnifications as to Debts and Liens;
- 4. Tax Proration Agreements;
- 5. Seller's Affidavits and Agreements;
- 6. Errors and Omissions Correction Agreements; and
- 7. Execution of any other approved document as directed by Fannie Mae.



The rights, powers, and authority of the Attorney-in-Fact to exercise the rights and powers herein granted shall commence and be in full force and effect until the first to occur of the following:

- 1. December 31, 2019; or
- 2. the execution and recording of a Termination of Limited Power of Attorney by Fannie Mae of such rights, powers, and authority.
