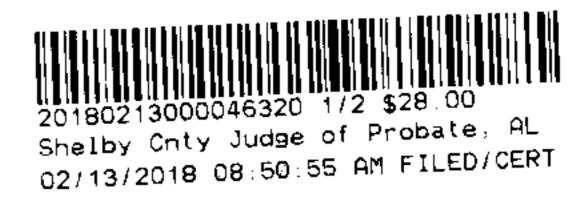
WARRANTY DEED

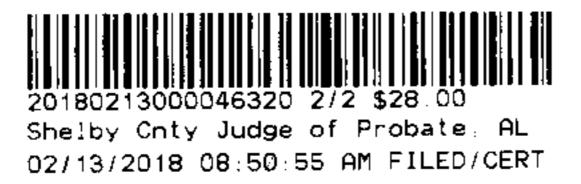

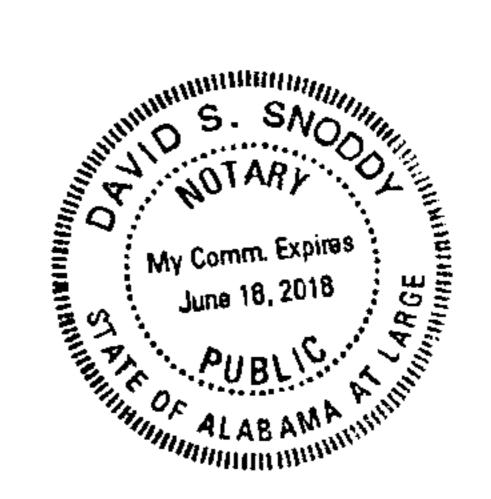
