FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on March 18, 2009, to-wit: Elizabeth Ruth Dodd and Danny Ray Dodd, wife and husband, executed a mortgage to Mortgage Electronic Registration Systems, Inc., solely as nominee for Everett Financial, Inc., DBA Supreme Lending, A Texas Corporation, its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on March 25, 2009, in Instrument No. 20090325000110030 and modified by that certain Loan Modification Agreement recorded April 22, 2015, in Instrument No. 20150422000130170, Probate Records of Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; which said mortgage was subsequently assigned to JPMorgan Chase Bank, National Association, by assignment recorded March 1, 2013, in Instrument No. 20130301000086250, Probate Records of Shelby County, Alabama; and

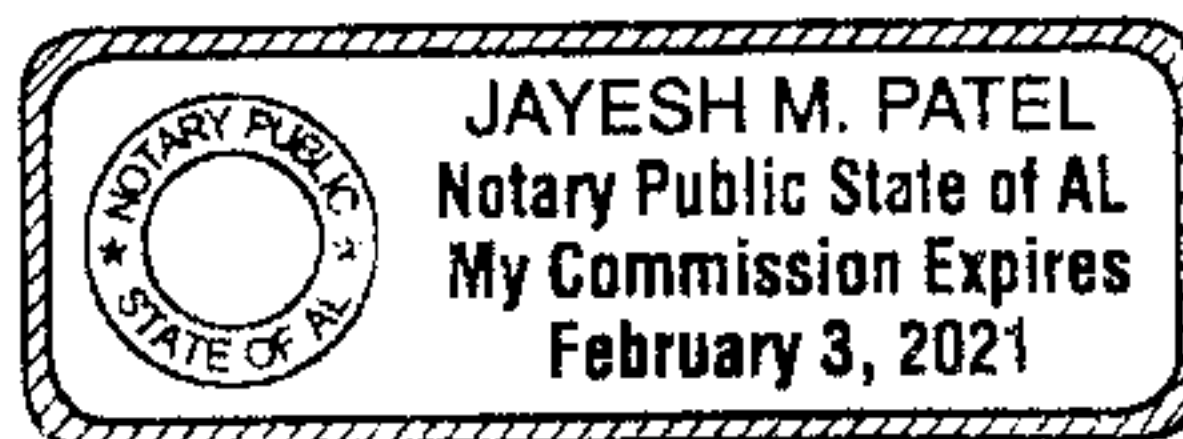
