or other assessments. The new principal balance of my Note is \$183,034.77 ("New Principal Balance").

C. The Interest Bearing Principal Balance will re-amortize over 346 months.

Interest will begin to accrue as of FEBRUARY 01, 2018. The first new monthly payment on the New Principal Balance will be due on MARCH 01, 2018, and monthly on the same date thereafter.

My payment schedule for the modified Loan is as follows:

Interest will accrue on the New Principal Balance at the rate of 4.000% annually. The monthly payment amount for principal and interest will be \$892.23, which is an amount sufficient to amortize the New Principal Balance over a period of 346 months.

- E.
