LITTLE, a married person**, (herein referred to as "Grantor"), in hand paid by the Grantee herein, the receipt whereof is hereby acknowledged, the Grantor does hereby give, grant, bargain, sell and convey unto the GRANTEE, **SHELBY INVESTMENT HOLDINGS, LLC**, (herein referred to as "Grantee"), Grantee's heirs and assigns, any and all of the respective Grantor's interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

The Northeast Quarter of the Southwest Quarter of Section 14, Township 19 South, Range 1 East. Situated in Shelby County, Alabama, ALSO, a 30 foot easement granted to Alabama Forest Products, Inc. by Great Eastern Timber Company LLC as described in Inst. No. 2001-35029.

6. All matters, facts, easements, restrictions, assessments, covenants, agreements and all other terms and provisions of record.



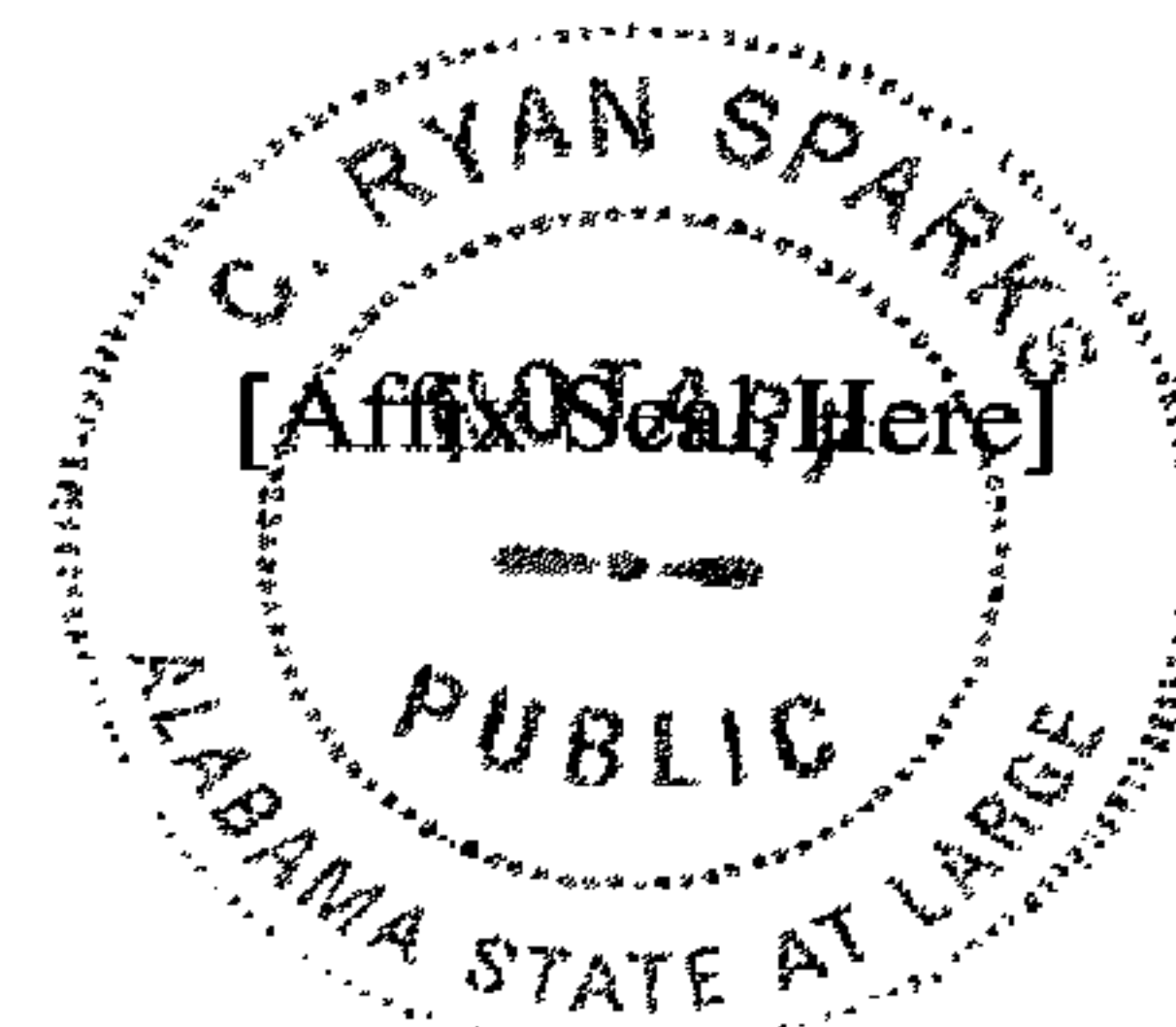
