COMES NOW the City of Alabaster, an Alabama municipal corporation, by and through its Finance Director, John Haggard, pursuant to the provisions of Alabaster Code of Ordinances (2015) Section 38-54(f), as amended, and Ala. Code § 40-1-2, and files this **Certificate of Tax Lien** for unpaid sales and use, in the amount of **\$5,437.29** plus additional penalties and interest, if applicable, against any and all property, real or personal or mixed, tangible or intangible, of whatever nature, now owned by and belonging to or which may hereafter be acquired by or transferred to said Taxpayer, for the amount of these taxes and all additional penalties, interest and costs that may accrue.

As provided by Section 41-1-2, and other applicable provisions of Alabama law, the City of Alabaster has hereby given notice that said taxes (including interest and penalties where applicable) have been duly assessed against the above-named taxpayer. The City of Alabaster has made demand for payment of this tax liability, and a repayment agreement thereon defaulted, and it remains unpaid. Therefore, there exists a tax lien in favor of the City of Alabaster as here in above provided. Although said above referenced amount of this lien includes applicable penalties, interest and other charges as of the date of this filing, additional interest continues to accrue at the prevailing statutory rate.


