

**DOMESTIC LIMITED LIABILITY COMPANY
ARTICLES OF ORGANIZATION**

Pursuant to the provisions of the Alabama Limited Liability Company Act, §10-12-1 et. seq., Code of Alabama (1975), as amended, the undersigned hereby adopts the following Articles of Organization:

ARTICLE I

The name of the Limited Liability Company shall be: **UWIN Systems LLC.**

ARTICLE II

The period of duration shall be: **Fifty (50) years from and after the date of the formation of the Limited Liability Company unless the Limited Liability Company is earlier dissolved in accordance with either the provisions of the Operating Agreement or of the Alabama Limited Liability Company Act.**

ARTICLE III

The Limited Liability Company has been organized for the following purpose:

- A) providing information technology consulting and services of any nature; and**
- B) any other lawful purpose or purposes.**

ARTICLE IV

Subject to contrary provisions in the Operating Agreement, additional Members may be admitted pursuant to the provisions of the Alabama Limited Liability Company Act.


ARTICLE VII

The Limited Liability Company shall be managed by: its Members.

Any provisions not inconsistent with the law for the regulation of the internal affairs of the Limited Liability Company are permitted to be set out in the Operating Agreement of the Limited Liability Company.
