



Commence at the Northwest corner of Section 6, Township 21 South, Range 2 East; thence run North 89 degrees 30 minutes East a distance of 660.0 feet; thence run South 0 degrees 37 minutes West a distance of 660.0 feet; thence run North 89 degrees 30 minutes East a distance of 313.20 feet to the West right of way line of Highway 25; thence turn an angle of 27 degrees 43 minutes to the right and run a distance of 66.0 feet to the East right of way line and the Point of Beginning; thence turn an angle of 4 degrees 06 minutes to the right and run a distance of 216.14 feet; thence turn an angle of 90 degrees 00 minutes to the right and run a distance of 115.30 feet; thence turn an angle of 88 degrees 43 minutes to the right and run a distance of 215.78 feet to the East right of way line of Highway 25; thence turn an angle of 91 degrees 07 minutes to the right and along said right of way a distance of 118.88 feet to the POINT OF BEGINNING.
