WARRANTY DEED - JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

Lot 8, according to the Survey of Forest Hills, 1st Sector, as recorded in Map Book 19, Page 46 A & B, in the Office of the Judge of Probate of Shelby County, Alabama.

Subject to:

- (1) ad valorem taxes for the current year and subsequent years;
- (2) restrictions, reservations, conditions, and easements of record, if any; and
- (3) any minerals or mineral rights leased, granted, or retained by prior owners.

TO HAVE AND TO HOLD unto the said Grantees for and during their joint lives as joint tenants, and upon the death of either of them, then to the survivor in fee simple, and to the heirs and assigns of such survivor forever, together with every contingent remainder and right of reversion.

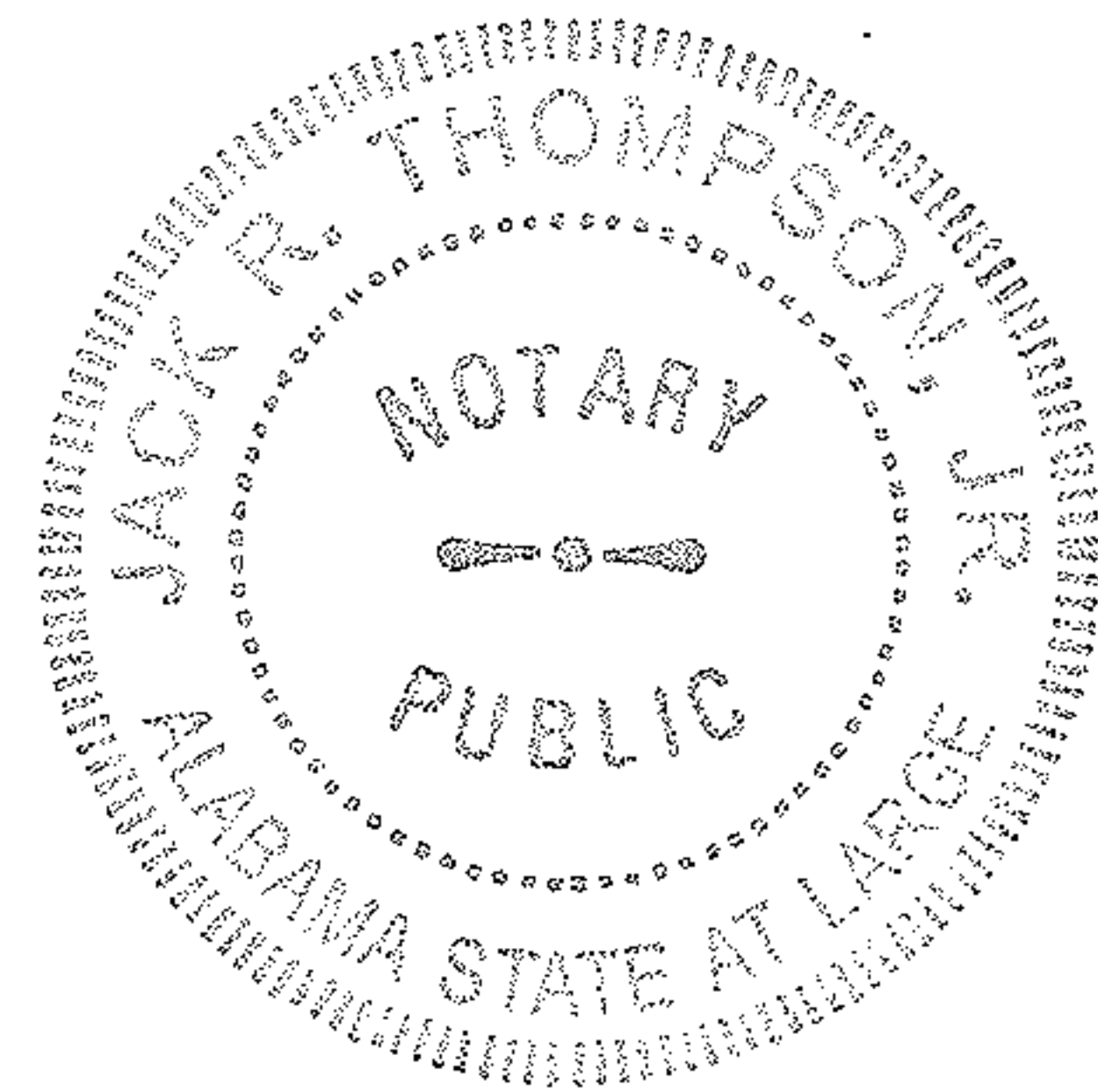
