Svhlik, a Married Man (herein referred to as grantor(s), whether one or more), grant, bargain, sell and convey unto Michael Aurilio and Elise Aurilio (hereinafter referred to as grantee(s), whether one or more), the following described real estate situated in Shelby County, Alabama to-wit:

The above described does not constitute the homestead of the grantor nor grantor's spouse.




