Know All Men by These Presents: That in consideration of **One Hundred Twelve Thousand Nine Hundred Fifty-Five and no/100 Dollars (\$112,955.00)**, to the undersigned Grantor, in hand paid by the Grantee herein, the receipt where is acknowledged, **CLAYTON 47 INVESTMENTS, LLC**, (herein referred to as Grantor), does hereby grant, bargain, sell and convey unto **MICHAEL F. ROBINSON and SANDRA P. ROBINSON** (herein referred to as Grantees), the following described real estate, situated in **Shelby** County, Alabama, to-wit:

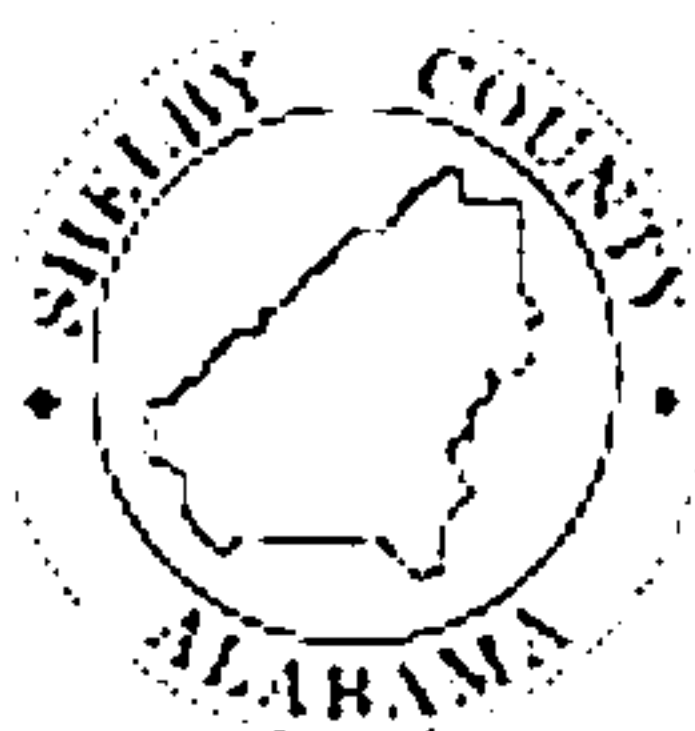
