Grantors herein are all the Heirs at Law of Wiltha Kelley, deceased, having died on November 8, 1998.

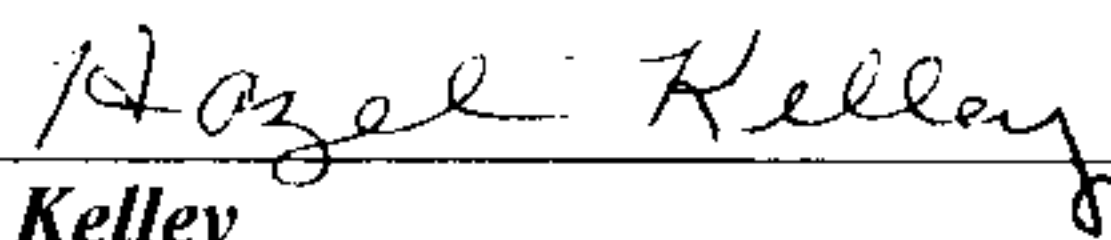
No part of the homestead of the grantors herein.

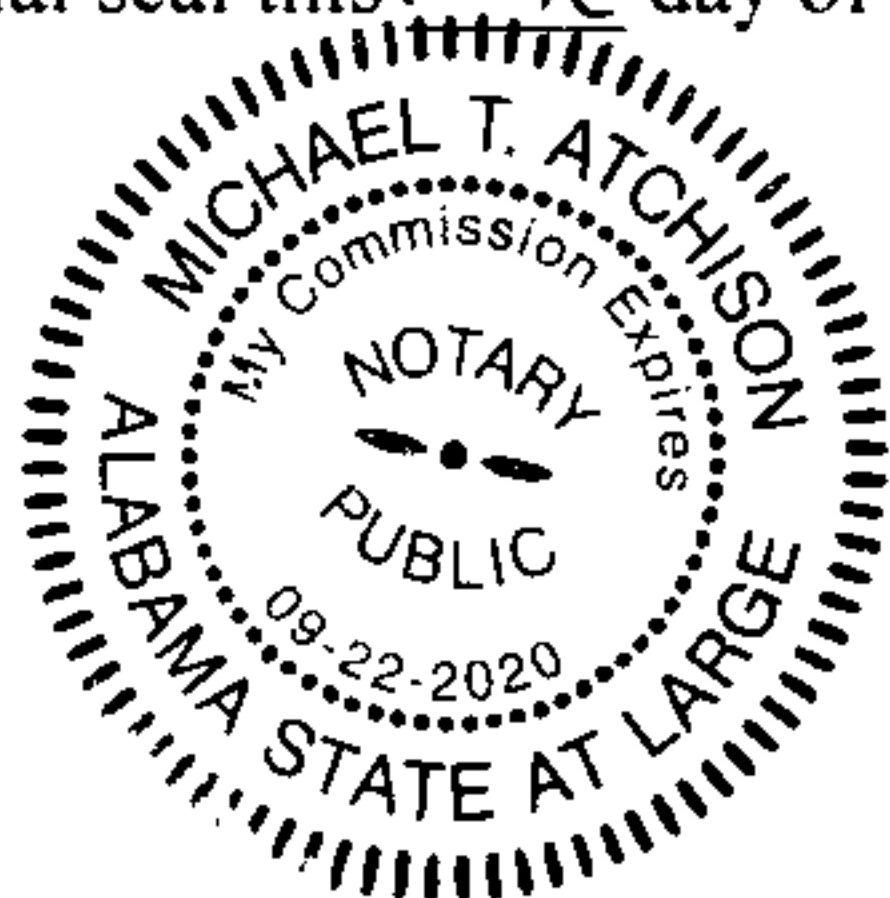

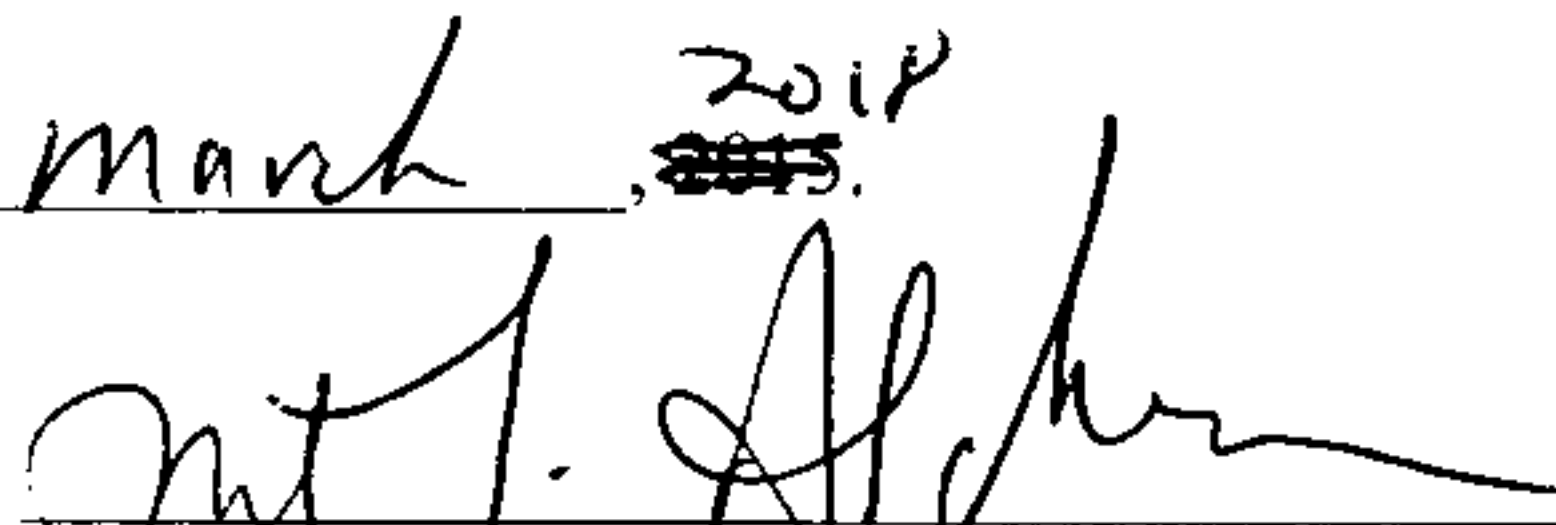

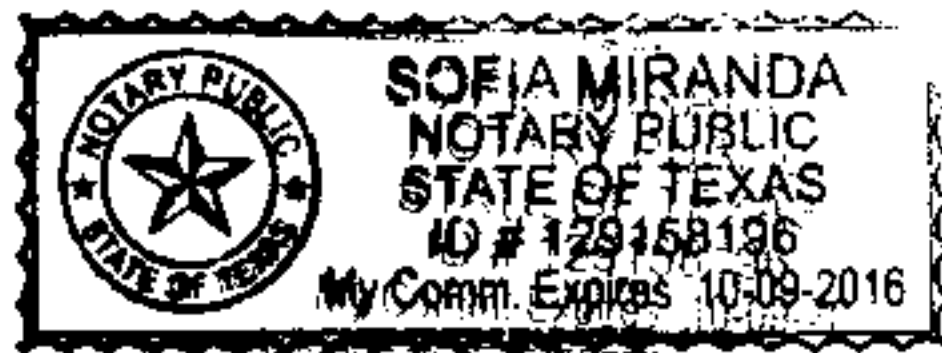

Commence at the Southeast corner of the SW¹/₄ of the NW¹/₄ of Section 27, Township 19 South, Range 2 East, Shelby County, Alabama; thence proceed West along the South boundary of said Quarter Quarter Section for a distance of 222.85 feet to the point of beginning of the land herein described. From this beginning point, continue West along the South boundary of said Quarter Quarter Section for a distance of 315 feet to a point; thence turn an angle of 90 deg. to the right and proceed North for a distance of 210 feet to a point; thence turn an angle of 90 deg. to the right and proceed East for a distance of 315 feet to a point; thence turn an angle of 90 deg. to the right and proceed South for a distance of 210 feet to the point of beginning.
