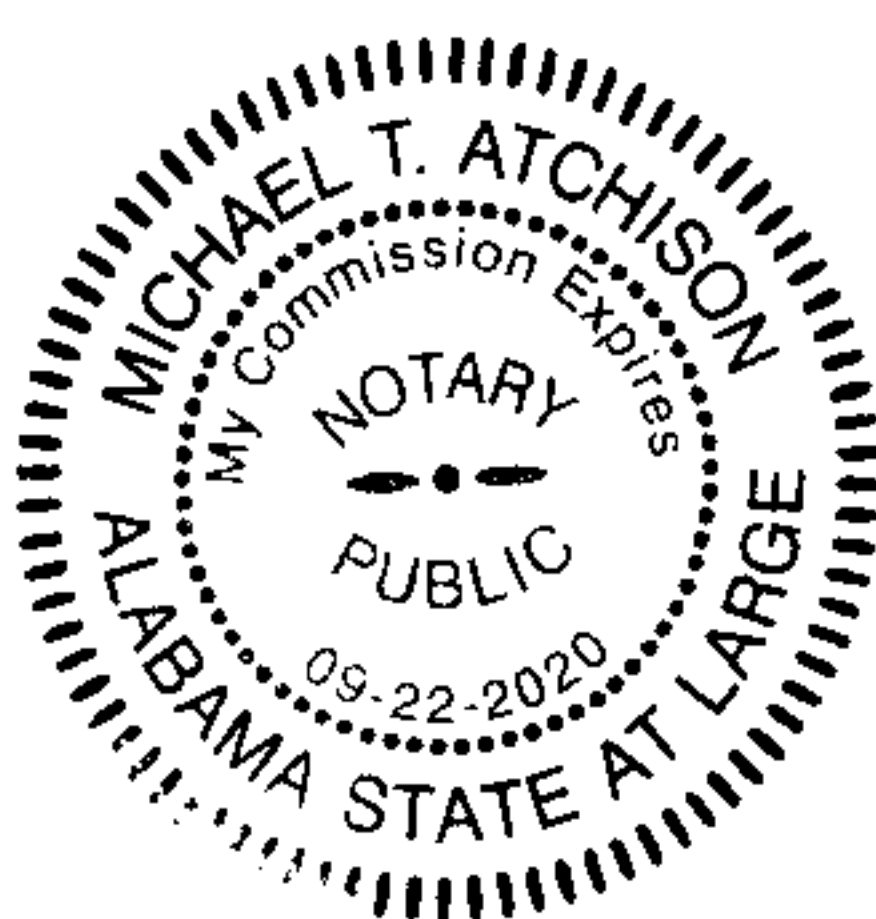

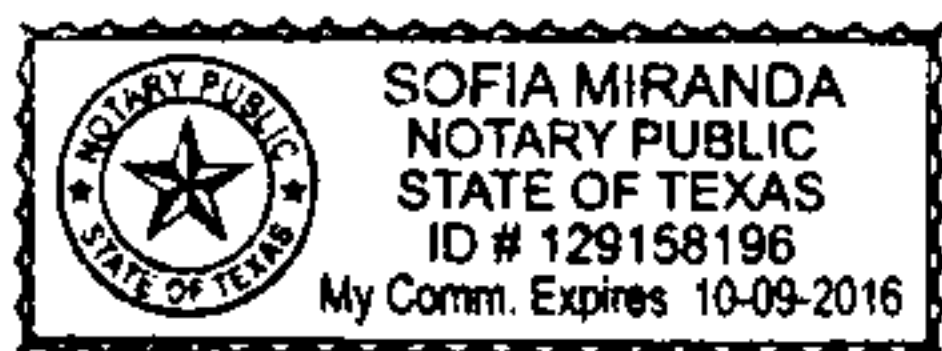

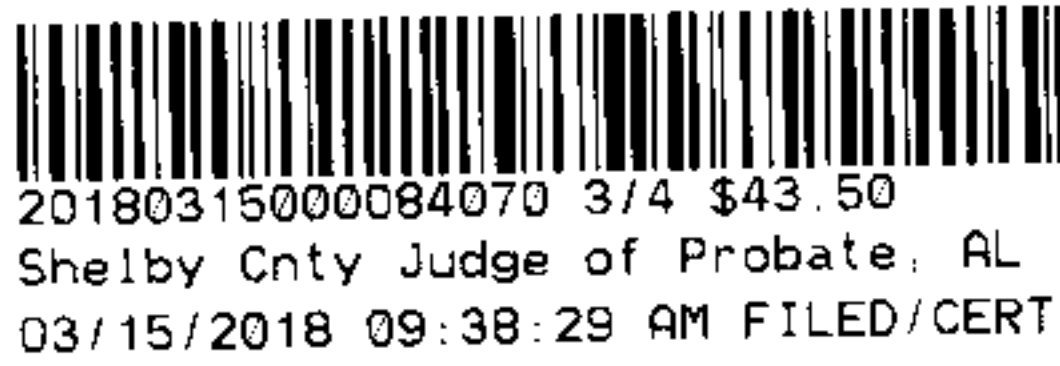

EXHIBIT A – LEGAL DESCRIPTION

A part of the E ½ of the SW ¼ of Section 27, Township 19, South Range 2 East, described as follows:

Commence at the SW corner of Section 27, Township 19 South, Range 2 East, and run North 54 degrees 45 minutes East a distance of 1313.98 feet, thence turn an angle of 10 degrees 46 minutes to the right and run a distance of 981.0 feet to the SE corner of Beenie Fair lot and the point of beginning; said point being on the North right of way line of Shelby County Highway No. 62; thence turn an angle of 1 degree 58 minutes to the left and run along said right of way line a distance of 105.0 feet; thence turn an angle of 62 degrees, 25 minutes to left and run a distance of 420 feet; thence turn an angle of 117 degrees 34 minutes to the left and run a distance of 105 feet to the NE corner of Beenie Fair lot; thence turn an angle of 62 degrees 26 minutes to left an run a distance of 420 feet to the point of beginning.
