PARTIAL RELEASE OF LIEN

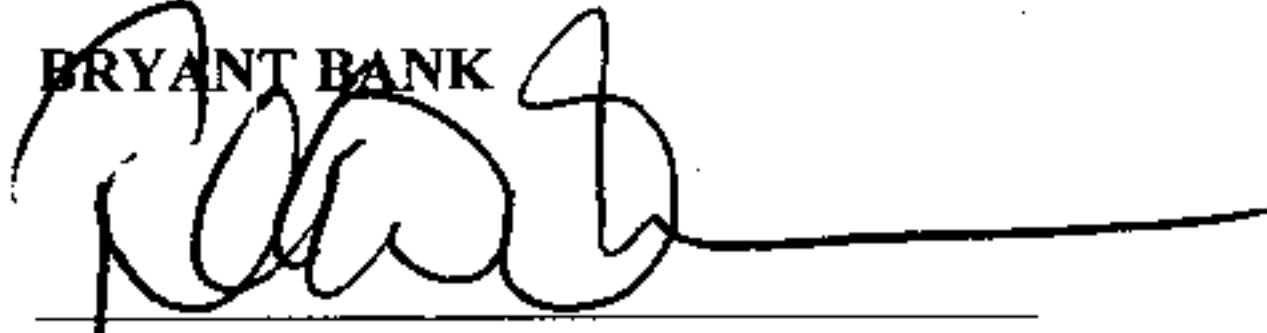

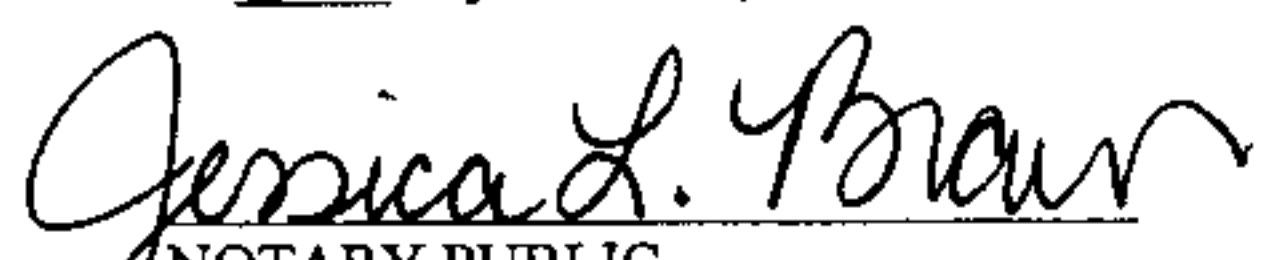
