ARTICLES OF ORGANIZATION
(CERTIFICATE OF FORMATION)
OF

The undersigned, for the purpose of forming a limited liability company pursuant to the provisions of the Alabama Limited Liability Company Act (the "Act"), §§ 10A-5-1.01, et seq., Code of Alabama, certifies as follows:

NAME. The name of the limited liability company (the "Company") is:

THE MENDED FENCE, LLC

DURATION. The period of the Company's duration shall be perpetual, provided that the Company shall be dissolved and its affairs shall be wound up upon the occurrence of any event of dissolution specified in the Act.


PURPOSE. The Company may transact any lawful business for which a limited liability company may be formed under the Act, but nothing contained herein shall be construed as authorizing the Company to carry on the business of banking or insurance or to act as a trust company, securities broker, securities dealer or investment advisor.

The cessation of membership of all members will result in the dissolution of the Company unless the holders of all financial rights in the Company agree in writing, within ninety (90) days after the cessation of membership of the last member, to continue the legal existence and business of the Company and to appoint one or more new members.

MANAGEMENT OF THE COMPANY. The Company shall be managed by its members.

INDEMNIFICATION. The Company may indemnify its members, managers, officers, agents and employees to the maximum extent permitted by law.

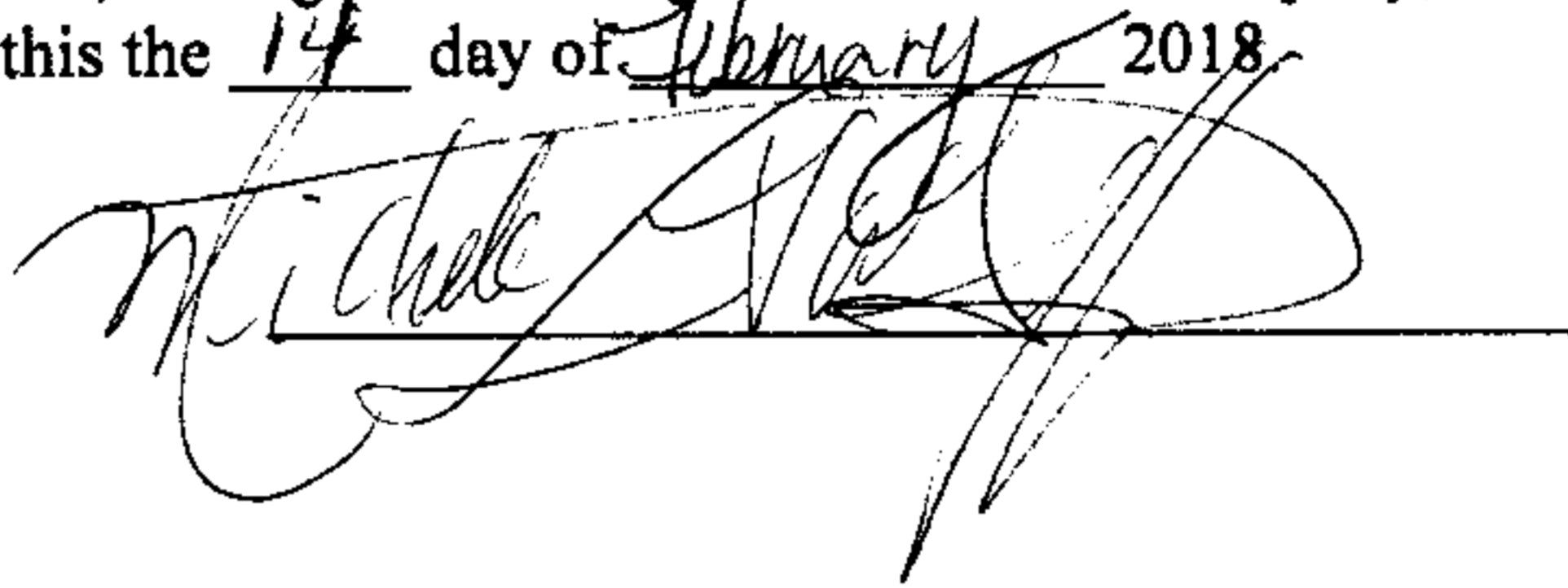
