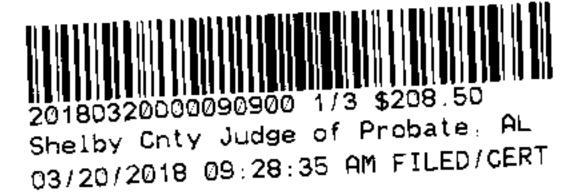

STATUTORY WARRANTY DEED (1/6th undivided interest in 220 acre tract)

KNOW ALL MEN BY THESE PRESENTS THAT:

WHEREAS, the undersigned, Catherine Yeilding Olson, as the Trustee of the Manly Yeilding Lake Trust f/b/o Catherine Yeilding Olson dated December 18, 1992, is the owner of a one-sixth (1/6th) undivided interest in and to the hereinafter described real property;
