

**ARTICLES OF ORGANIZATION

The undersigned, for the purposes of forming a limited liability company (the "Company") pursuant to the provisions of the Alabama Limited Liability Company Act (the "Act") (Alabama Code §10-12-1, et seq.) hereby certify as follows:

1. NAME OF COMPANY. The name of the Company is:

**"BCH HOLDINGS, LLC"**

2. PERIOD OF DURATION. The period of duration of the Company shall be perpetual.

3. COMPANY PURPOSES. The Company has been organized for the purpose of conducting any legal activities of a limited liability company. The Company may also transact any other lawful business for which a limited liability company may be formed under the Act, but nothing contained herein shall be construed as authorizing the Company to carry on the business of banking or insurance or to act as a trust company. Furthermore, nothing contained herein shall be construed as authorizing the Company to act as a securities broker, a securities dealer or as an investment advisor.
