If my representations in Section 1 continue to be true in all material respects, then the provisions of Section 2 of this Loan Modification Agreement ("Agreement") will, as set forth in Section 2, amend and supplement (i) the Mortgage on the Property, and (ii) the Note secured by the Mortgage. 
2. The Modification.

A. The Maturity Date will be: JANUARY 01, 2047.

- B. The modified principal balance of my Note will include all amounts and arrearages that will be past due (excluding unpaid late charges) and may include amounts toward taxes, insurance, or other assessments. The new principal balance of my Note is \$98,774.35 ("New Principal Balance").
- C. The Interest Bearing Principal Balance will re-amortize over 346 months.

Interest will begin to accrue as of MARCH 01, 2018. The first new monthly payment on the New Principal Balance will be due on APRIL 01, 2018, and monthly on the same date thereafter.

My payment schedule for the modified Loan is as follows:

Interest will accrue on the New Principal Balance at the rate of 4.000% annually. The monthly payment amount for principal and interest will be \$481.49, which is an amount sufficient to amortize the New Principal Balance over a period of 346 months.






- D.
