

CERTIFICATE OF FORMATION
OF
CHRISTOPHER OAKS, LLC

The undersigned, pursuant to the Alabama Limited Liability Company Law of 2014, for the purpose of forming a limited liability company under the laws of the State of Alabama do hereby adopt the following Certificate of Formation:

ARTICLE I
NAME

The name of the limited liability company is Christopher Oaks, LLC, which is hereinafter referred to as "the Company."

ARTICLE II
PERIOD OF DURATION

The period of duration of the Company shall be from the date of filing until dissolution of the Company pursuant to provisions of the Alabama Limited Liability Company Law of 2014 or the Limited Liability Company Agreement.

ARTICLE III
PURPOSES

The purposes for which the Company is formed are to do any and all things hereafter set forth, to the same extent as natural persons in any part of the world, namely:

(a) Principal Purposes. To operate a company for the purpose of acquiring by purchase, lease, or otherwise and to improve and develop real property. To erect dwellings, apartment houses, and other buildings, private or public, of all kinds, and to sell or rent the same. To lay out, grade, pave, and dedicate roads, streets, avenues, highways, alleys, courts, paths, walks, parks, and playgrounds. To buy, sell, mortgage, exchange, lease, let, hold for investment or otherwise, use, and operate real estate of all kinds, improved or unimproved, and any right or interest therein and to have the ability for the member to take any and all actions authorized by these Articles and the Alabama Limited Liability Company Law of 2014.

(b) Ancillary Purposes. To do everything necessary, proper, advisable, or convenient for the accomplishment of the foregoing purposes, and to do all other things incidental to them or connected with

them that are permitted or not forbidden by the Alabama Limited Liability Company Act, by other law or by these Articles of Organization.

ARTICLE IV

POWERS

The company and its members shall have the powers to conduct all lawful business in the State of Alabama and any other jurisdiction in which it is so authorized and to exercise any and all powers under the Alabama Limited Liability Company Law of 2014 and as set forth in the Company Agreement.

ARTICLE V

ADDRESS AND REGISTERED AGENT

The initial registered office of the limited liability company is **113 Waterloo Bend, Birmingham, Alabama 35242** and the initial registered agent at that address is **Brad Christopher**.

ARTICLE VI

MEMBERSHIP

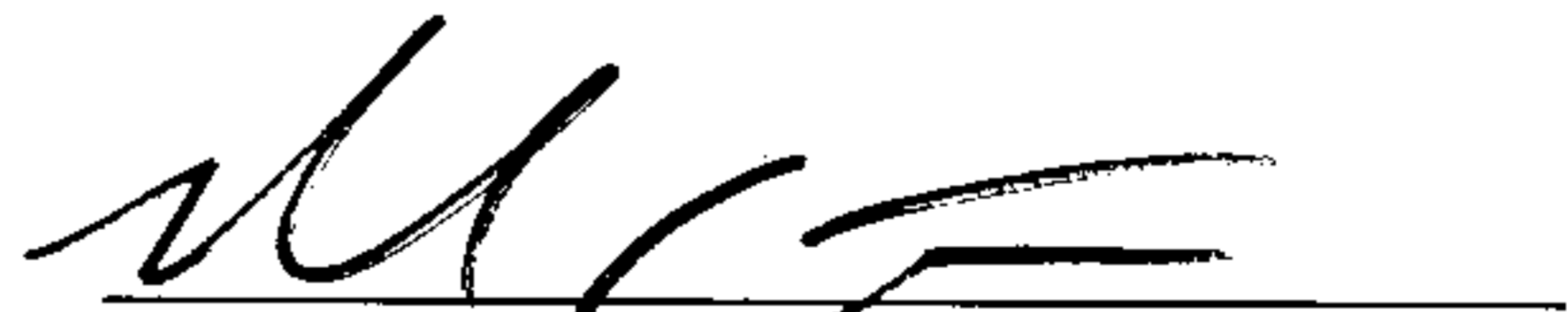
There is at least one member of the limited liability company.
